NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – Art Alive - Bloom Bash 2023 **COMMUNITY PLAN AREA:** Balboa Park **COUNCIL DISTRICT:** 3 **LOCATION:** Plaza de Panama in front of the Museum of Art – Balboa Park

PROJECT DESCRIPTION: Special Event Permit for a botanical art Bloom Bash kickoff party event on March 31, 2023 in the Plaza de Panama in front of the Museum of Art in Balboa Park. The event would include the temporary use of food stations, a stage, tents and canopies, temporary structures, onsite food preparation, a beer garden, generators, fencing and/or barriers, tables and chairs, sound amplification, entertainment, recycling and trash containers. Alcohol would be served from 7 PM until 11:30 PM. Sound amplification for announcements, music, and entertainment would occur from 5 PM until 11:55 PM. Noise associated with the event activities and set-up/dismantling would occur from 8 AM on March 27, 2023, until 4 AM on April 1, 2023. Set-up would occur from 8 AM until 5 PM on March 27-30, 2023, and from 8 AM until 7 PM on March 31, 2023. The event would occur on March 31, 2023 from 7 PM until 11:59 PM. And dismantling would occur from 12 AM until 4 AM the next morning on April 1, 2023. Approximately 1,500 attendees are anticipated to attend during the course of the event.

There would be no road closures associated with this event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal**, **MS 2A**, **202 C Street**, **San Diego**, **CA 92101**.
