## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit – Archipelago Bike Ride

**COMMUNITY PLAN AREA:** Black Mountain Ranch

**COUNCIL DISTRICT:** 5

LOCATION: Black Mountain Ranch Park, 99 Twenty Building -9920 Pacific Heights Blvd., San Diego, CA

**PROJECT DESCRIPTION:** Special Event Permit for a cycling event which would include routes, aid stations, beer garden and the temporary use of tents, tables, fencing and/or barriers, recycling and trash containers, portable restrooms. Alcohol would be served from 11:10 AM until 6:30 PM on April 1, 2023. The route ride would begin at San Elijo Park in San Marcos and end at the 99 Twenty Building (9920 Pacific Heights Boulevard. See map attached. The event would occur on April 1, 2023. Noise associated with the event activities and set-up/dismantling would occur from 6 AM until 7 PM on April 1, 2023. On April 1, 2023, set up would occur from 6 AM to 7 AM, the event would occur from 7 AM to 6 PM, and dismantling would occur from 6:10 PM to 7 PM. Approximately 500 attendees are expected to attend.

No road closures would be associated with this event.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
