NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Good Friday Walk With the Suffering

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Elm St, Third Ave, E St, Union St, B St, Front St, F St, and Ash St

PROJECT DESCRIPTION: Special Event Permit for a Good Friday walking procession through the downtown area that would occur on April 7, 2023. Noise associated with the event activities would occur between 8 AM and 11:30 AM on April 7, 2023. Set-up would occur from 8 AM until 8:30 AM and the event would occur from 8:30 AM until 11:30 AM. The procession would make stops for reflection and prayer, and stops would include the San Diego Rescue Mission, First Presbyterian Church, St. Joseph Catholic Cathedral, First Lutheran Church, the City Administration Building (Civic Plaza), the Federal Building, Metropolitan Correctional Center, State Office Building, and returning to the Rescue Mission. The procession would start out at the driveway on the east side of the Rescue Mission at Second and Date, then proceed west to Third Ave., south to Date Street, stop at First Presbyterian Church, then south to St. Joseph Cathedral at Third and Beech, then south to First Lutheran at Third and Elm. Proceed south to the Civic Plaza at Third and B, then continue south to E Street, turning west to the Federal Building at 880 Front Street. From there proceed one block west to MCC building on Union St. and F Street, then proceed north on Union to B St, east on B to the State Office Building on Front. Street, then north on Front St to Ash, east on Ash to Third Avenue and north to Elm, end west on Elm to Second Ave. at the Rescue Mission.

The procession would follow rules of the road and no road closures would be associated with this event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
