NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – La Jolla Concours d'Elegance 2023

COMMUNITY PLAN AREA: La Jolla

COUNCIL DISTRICT: 1

LOCATION: Ellen Browning Scripps Park and La Jolla Village

PROJECT DESCRIPTION: Special Event Permit for a 3-day event antique car show that would occur on La Jolla Village Streets and Ellen Browning Scripps Park on April 21-23, 2023. The event would consist of the temporary use of alcoholic beverages, cars, a stage, sound amplification, tents and/or canopies, tables, chairs, temporary structures, a beer garden, fencing and/or barriers, generators, food trucks, food sampling and prepackaged food, portable restrooms, recycling and trash containers, and entertainment. Noise associated with the event activities and set-up/dismantling would occur from April 20, 2023 at 6 AM to 10 PM on April 24, 2023. Set-up would occur from 6 AM until 10 PM on April 20th and 22nd, and from 6 AM until 6 PM on April 21, 2023. Day 1 of the event would occur on April 21st from 6 PM to 10:30 PM, day 2 on April 22nd from 5 PM until 10 PM, and Day 3 on April 23rd from 8 AM until 5 PM. Dismantling would occur from April 23, 2023 at 5 PM until 10 PM and on April 24, 2023 from 8 AM until 10 PM. Sound amplification from entertainment would occur from 9 AM until 10 PM on each event date. Ellen Browning Scripps Park would be closed to the public from 6 AM on April 20, 2023 through 4 PM on April 24, 2023.

Street parking would be closed for public parking on the following streets: both sides of Coast Boulevard between Prospect Street and Girard Avenue, Girard Avenue between Coast Boulevard and Prospect Street, and Ivanhoe Avenue between Prospect and Cave Streets from 2 AM until 8 PM on April 23, 2023; both sides of Cave Street between Prospect and Ivanhoe from 4 AM until 9 AM on April 23, 2023; the North curb of Coast Boulevard in front of Ellen Browning Park from 6 AM on April 20, 2023 until 10 PM on April 23, 2023; Coast Boulevard between Prospect Street and Girard Avenue, Girard Avenue between Coast Boulevard and Prospect Street, Prospect between Girard and Herschel Street, and Herschel Street between Prospect and Wall on south side for ADA parking from 2 AM until 5:10 PM on April 23, 2023; on the south side of Prospect St between Girard and Cave Street, Herschel between Prospect Street and Wall Street (both sides), Ivanhoe Avenue between Prospect and Roslyn (both sides) from 3 PM until 11 PM on April 21, 2023; and the corner of Herschel and Prospect from 7 AM until 7 PM on April 22, 2023.

Road closures associated with this event would occur on April 23, 2023 from 2 AM until 8 PM on Coast Boulevard between Prospect Street and Girard Avenue, on Girard Avenue between Coast Boulevard

and Prospect Street. Coast Boulevard would be closed to thru traffic except for businesses and residents on April 23, 2023 from 2 AM until 8 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
