NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – 53rd Annual Chicano Park Day Commemoration

COMMUNITY PLAN AREA: Barrio Logan

COUNCIL DISTRICT: 8

LOCATION: Chicano Park in Barrio Logan

PROJECT DESCRIPTION: Special Event Permit for an all-day family celebration event that would include a car exhibition, bands, cultural music groups, cultural dance groups, speakers, children's' activities, food preparation, two stages, and the temporary use of generators, portable restrooms, trash and recycling containers, that would occur in Chicano Park and on Logan Avenue on April 22, 2023. Noise associated with the event activities and set-up/dismantling would occur from 3 AM until 7 PM on April 22, 2023. On April 22, 2023, set-up would occur from 3 AM until 9 AM, the event would occur from 10 AM until 5 PM, and the event would be dismantled from 5 PM until 7 PM. There would be two stages with entertainment performances and speakers, and sound amplification would occur from 9 AM until 5 PM. The park parking lot would be unavailable to the public from 3 AM until 7 PM on April 22, 2023.

Road closures would be associated with the event and would occur from 4 AM until 7 PM on April 22, 2023 and include Logan Avenue between Cesar Chavez Parkway and South Evans Street, National Avenue between Cesar Chavez to Highway 75 off ramp.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
