NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – San Diego Beach & Bay Half Marathon

COMMUNITY PLAN AREA: Mission Bay Park and Mission Beach

COUNCIL DISTRICT: 2

LOCATION: Tecolote Shores South Park, Mission Bay Park and Mission Beach; Fiesta Island

PROJECT DESCRIPTION: Special Event Permit for a half marathon race event that would include the half marathon route, the 5K and 10K routes, a fenced-in beer garden, tents, barriers, vendors, food trucks, food preparation, entertainment, sound amplification, three stages, portable restrooms, canopies, a drone, trash and recycling containers that would occur within Mission Bay on April 23, 2023. Sound amplification from performances would occur from 6 AM until 11:30 AM on April 23, 2023. Noise associated with the event activities and set-up/dismantling would occur from 9 AM on April 23, 2023, until 1 PM on April 27, 2023. Set-up would occur from 9 AM until 6 PM on April 22, 2023, the event would occur from 3 AM until 12 PM on April 23, 2023, and dismantling would occur on April 23, 2023 from 12 PM until 2 PM. The half marathon, 5K and 10K routes are shown on the attached maps. The event start and finish lines are at Tecolote Shores Park.

Road closures would be associated with the event on April 23, 2023 and would include the following: Fiesta Island closed to vehicle traffic from 4 AM until 9 AM; East Mission Bay Drive at Fiesta Island from 4 AM until 10 AM; from 4 AM until 10 AM E. Mission Bay Drive between Sea World Drive, Tecolote Shores south parking lot, Sea World Drive at E. Mission Bay Drive, Crown Point Drive from Lamont Street to Pacific Beach Drive; Corona Oriente no access to entrance of North Crown Point Park Parking Lot, and S. Shores from 4 AM until 7 AM;

Public parking would also be prohibited from 9 AM on April 22, 2023 to 9 AM on April 23, 2023 on East Mission Bay Drive from South Tecolote Parking lot to the North Tecolote Parking lot. Public parking would also be prohibited at this time within the South Tecolote Parking lot. From 4 AM until 2 PM on April 23, 2023 entrance to dirt parking lot at Fiesta Island entrance, both East and West curb lines of East Mission Bay Drive between Tecolote Shores Parking lot entrance Sea World Drive, both North and South curb lines of San Rafael, from boardwalk to the bay side, south curb line of Crown Point Drive from Lamont Street to Pacific Beach Drive, south curb line of Pacific Beach Drive from Crown Point Drive to Camp land entrance, west curb line of North Mission Bay Drive from pedestrian walkway to De Anza Trailer Park entrance.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

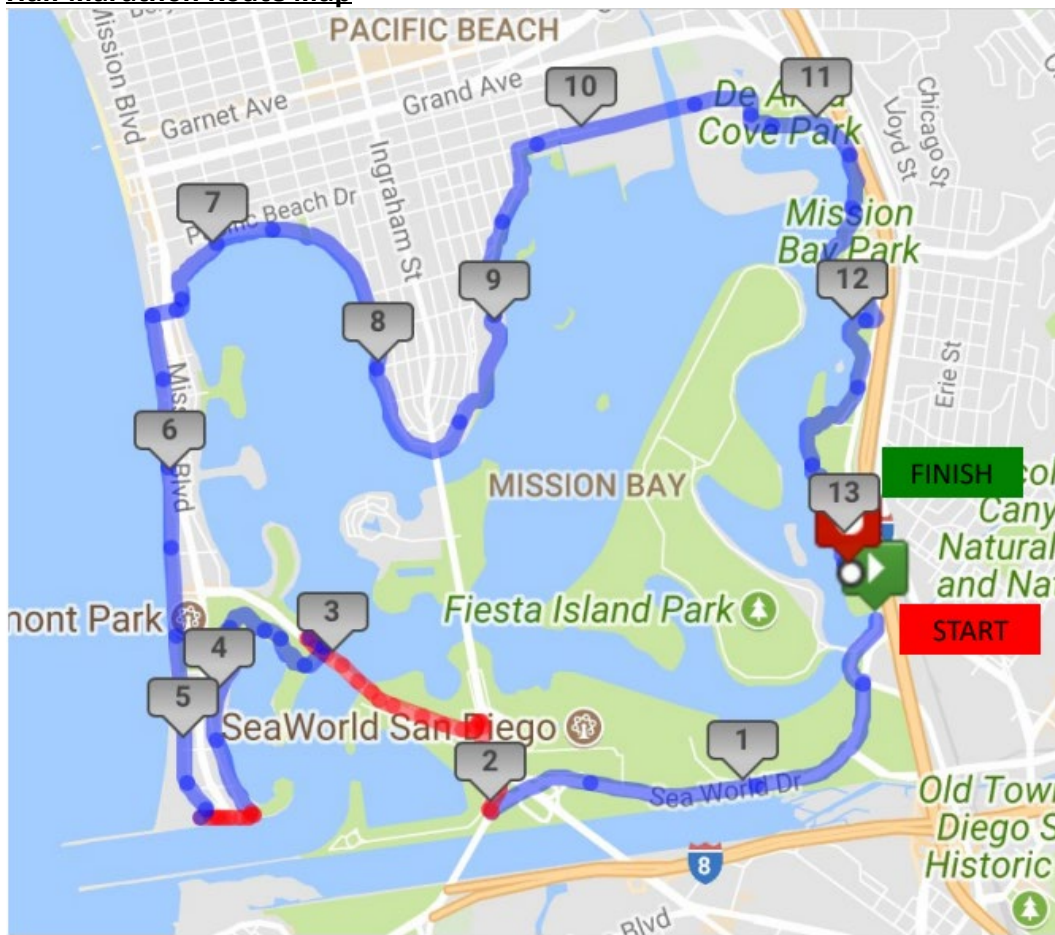

Half Marathon Route Map



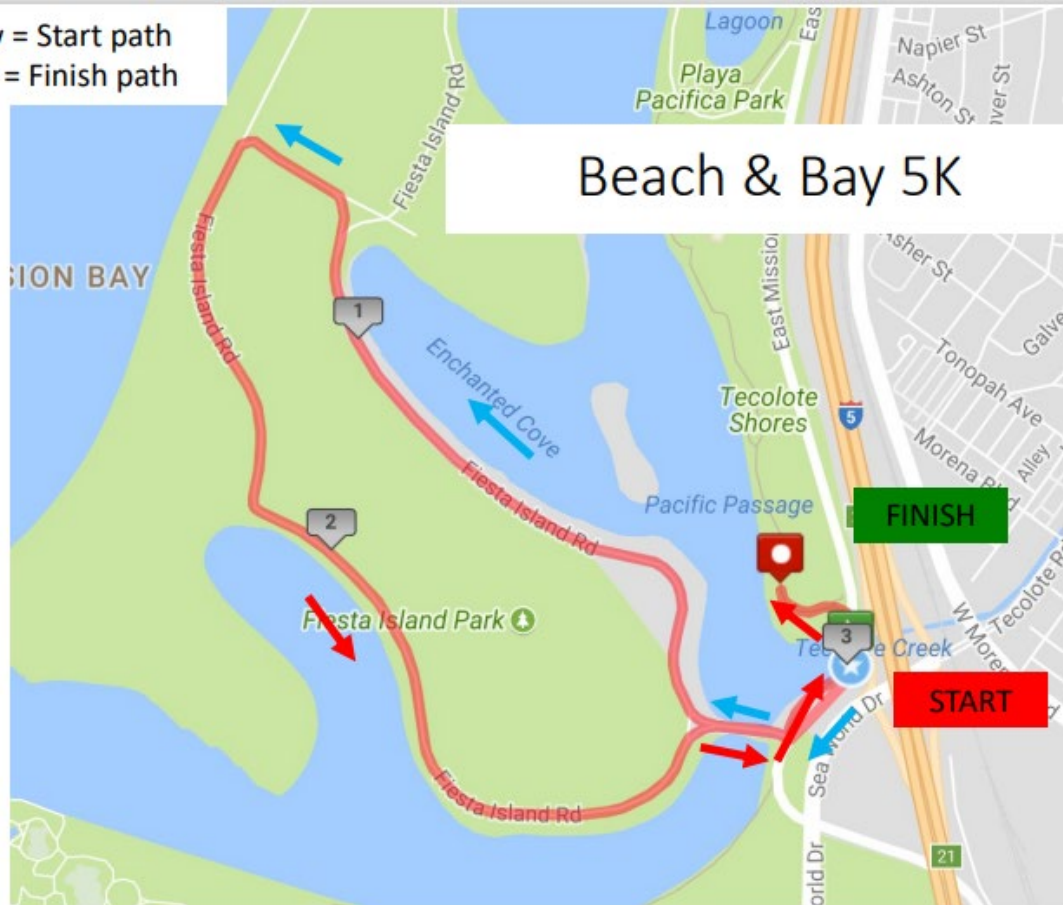
San Diego Beach & Bay Half Marathon

Turn by Turn Course Details

April 23, 2023

- Race starts on E. Mission Bay Drive near Sea World Drive
- Right turn on Sea World Drive
- Right turn on Sunset Cliffs Onramp
- Left on West Mission Bay Drive
- Right 1/8 mile before Gleason Drive just pass the bridge (through the grass)
- Runners continue onto sidewalk and under the bridge
- Continue on Bayside Walk
- Right turn on San Diego Place (turns into N. Jetty Road)
- Right turn on Ocean Front Walk
- Right turn on San Rafael Place
- Left turn on Bayside Walk
- Right turn on Corona Oriente Road
- Right on Crown Point Drive
- Right on Pacific Beach Drive
- Onto walking path behind Mission Bay High School
- Turns into N. Mission Bay Drive
- Right on DeAnza Road
- Left on Deanza Bayside walk
- Finish at Tecolote Shores Park North.
