## REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit – Abrazo 5K/10K Community WalkRun

**COMMUNITY PLAN AREA:** San Ysidro

**COUNCIL DISTRICT: 8** 

**LOCATION:** Sidewalks within San Ysidro, 4330 Camino De La Plaza

**PROJECT DESCRIPTION:** Special Event Permit for a 5K/10K community walk event that would include the route, entertainment, food and beverage vendors, fenced in beer garden, and the temporary use of canopies, a generator, portable restrooms, trash and recycling containers, tables, and chairs to occur on sidewalks of street of starting at 4330 Camino De La Plaza in San Ysidro on May 6, 2023. Noise associated with the event activities and setup/dismantling would occur from 2 AM until 4 PM on May 6, 2023. Sound amplification would be used for announcements/entertainment and would occur from 8 AM until 10:30 AM. On May 6, 2023, set-up would occur from 2 AM until 7AM, the event would occur from 7:15 AM until 11:30 AM, and dismantling would occur from 11:30 AM until 4 PM. Approximately 700 attendees are anticipated throughout the course of the event.

The 5K route would begin and end on public street in front of Kmart at 4330 Camino De La Plaza, San Ysidro, CA 92173. The return point would take place at 2721 Monument Rd, San Diego, CA 92154. See route map attached.

Parking closures would occur between 5 AM and 1 PM on May 6, 2023 and would include both sides of Camino de la Plaza between Kmart lot/Willow Road and Dairy Mart Road. Potential pedestrian delays would be associated with this event from 7 AM until 12 PM and would include the sidewalks along the route.

Road closures would be associated with the event and would include Camino De La Plaza between Willow Road and Dairy Mart Road, and Dairy Mart Road between Camino De La Plaza and Tijuana River Valley Park entrance from 5 AM to 1 PM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

## ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
