# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME:** Special Event Permit – Girls on the Run San Diego 5K

**COMMUNITY PLAN AREA:** Mission Bay Park

**COUNCIL DISTRICT:** 2

**LOCATION:** De Anza Cove Park and surrounding pathways; 3000 N Mission Bay Dr, 92109

**PROJECT DESCRIPTION:** Special Event Permit for the Girls on the Run 5K event that would include the route, a stage, entertainment, vendors, and the temporary use of canopies, portable restrooms, trash and recycling containers to occur in De Anza Cove Park area within Mission Bay Park on May 7, 2023. Noise associated with the event activities and set-up/dismantling would occur from 12pm on May 6, 2023 until 12 PM on May 7, 2023. A stage would be used for announcements/entertainment, and sound amplification would occur from 8 AM until 11:30 AM. On May 6, 2023, set-up would occur from 12 PM until 5 PM. On May 7, 2023 the event would occur from 7:30 AM until 12 PM, and dismantling would occur from 10:30 AM until 12 PM. Approximately 2000 attendees are anticipated throughout the course of the event. See route map and turn by turn directions attached.

Road closures would be associated with the event and would include De Anza Road between Mission Bay Drive and the dead end/turnaround from 8:30 AM until 9:30 AM, and Mission Bay Drive between De Anza Road and the parking lot turn off at 2194 E Mission Bay Drive from 8:30 AM until 10:30 AM on May 7, 2023.

The De Anza Cove parking lot would be unavailable for public use from 4 AM until 11 AM on May 7, 2023. See map attached.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

Distance	Turn-by-turn Directions
0.00 miles	Start at De Anza Cove Park near public restrooms
	Head west towards De Anza Road
0.10 miles	Turn right, head north on De Anza Road
0.21 miles	Turn right onto North Mission Bay Drive
0.38 miles	Slight right to stay on North Mission Bay Drive
0.49 miles	Continue straight on Mission Bay Drive
0.85 miles	Continue straight on Mission Bay Drive
1.69 miles	Turn right at entrance to parking lot at 2194 Mission Bay Drive
	Continue straight to meet up with Bayshore Bikeway
1.71 miles	Turn right on Bayshore Bikeway
1.88 miles	Continue straight on Bayshore Bikeway
2.48 miles	Slight left to stay on Bayshore Bikeway
3.13 miles	Finish at De Anza Cove Park near public restrooms
