NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – Metamorphosis COMMUNITY PLAN AREA: Barrio Logan COUNCIL DISTRICT: 8 LOCATION: 1805 Main Street, 92113

PROJECT DESCRIPTION: Special Event Permit for an art exhibit showcasing paintings, photography and sculptures on May 12, 2023, at the Monarch Schools performing art center "The Chrysalis" located on the corner of Main Street & Beardsley Street in Barrio Logan. The event would include alcohol, food trucks, food preparation, amplification, and music and the temporary use of tents, fencing and/or barriers, tables and chairs, portable restroom, trash and recycling containers. Noise associated with the event activities and set-up/dismantling would occur on May 12, 2023, from 8 AM until 11:55 PM. Set-up would occur from 8 AM to 5 PM, the event would occur from 5:30 PM to 8:30 PM, and dismantling would occur from 8:30 PM to 11:55 PM.

A road closure associated with the event would occur on Main Street from Beardsley Street to Cesar E Chavez Parkway from 8 AM to 11:45 PM on May 12, 2023.

Public parking spaces will be removed for the event on May 12, 2023 from 8 AM to 11:45 PM on 1800 block of Main Street from Beardsley Street to Cesar E Chavez Parkway.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
