# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME:** Special Event Permit – Kiwanis Tierrafest Parade

**COMMUNITY PLAN AREA:** Tierrasanta

**COUNCIL DISTRICT:** 7

**LOCATION:** 5156 Santo Rd., Tierrasanta Boulevard, Santo Road, La Cuenta Drive, Baroque Lane

**PROJECT DESCRIPTION:** Special Event Permit for a Tierrasanta Parade that would occur on May 20, 2023. The parade would include vehicle, floats, motorized, and marching units. Noise associated with the event activities and set-up/dismantling would occur from 7:30 AM until 11:55 AM on May 20, 2023. Sound amplification would occur from the parade announcers and music. Sound amplification from fireworks would occur from 9:45 AM until 11:30 AM. On May 20, 2023, set-up for the parade would occur between 7:30 AM and 9:45 AM, the parade would occur from 10 AM until 11:30 AM, and the parade would be dismantled between 11:45 AM and 11:55 AM. The parade would start at Canyon Hill High School, 5156 Santo Road, through the main commercial area on Tierrasanta Boulevard and ends on Baroque Lane. See route map attached. The assemble area would take place in the Canyon Hills Parking Lot. The parade would proceed south on Santo Road then east on Tierrasanta Boulevard to La Cuenta Drive, left on Baroque Lane to disperse at the Legacy Church Parking lot.

Road closures would occur from 10 AM until 12 PM and would include Tierrasanta Boulevard eastbound between Santo Road and La Cuenta Drive, La Cuenta Drive between Tierrasanta Boulevard and Baroque Lane, and Baroque Lane between La Cuenta Drive and Ducos.

Parking closures would occur from 7:30 AM until 12 PM and would include west curb of Santo Road from Canyon Hills High School to Tierrasanta Boulevard, Tierrasanta Boulevard between Santo Road and La Cuenta Drive, La Cuenta Drive between Tierrasanta Boulevard and Manacor Court, and Baroque Lane between La Cuenta Drive and parking lot before Ducos Place.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable
