NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – Raza Car Club Show
COMMUNITY PLAN AREA: Otay Mesa-Nester
COUNCIL DISTRICT: 8
LOCATION: Montgomery Waller Park, 3020 Coronado Ave, San Diego, CA 92154

PROJECT DESCRIPTION: Special Event Permit for a car show that would include display cars, car owners, food vendors/food trucks, merchandise vendors, and entertainment, food preparation, and the temporary use of a stage, tents/canopy, generator, fencing and/or barriers, portable restrooms, tables, chairs, and recycling and trash containers that would occur at Montgomery-Walker Park at the corner of Beyer Boulevard and Palm Avenue on June 10, 2023. Noise associated with the event activities and setup/dismantling would occur from 8 AM until 7 PM on June 10, 2023. There would be a stage with entertainment, and sound amplification would occur from 10 AM until 4 PM on June 10, 2023. On June 10, 2023, set-up would occur from 8 AM until 10 AM, the event would occur from 10 AM until 5 PM, and clean-up/dismantling would occur from 5 PM until 7 PM. Approximately 400 attendees are anticipated throughout the course of the event.

Twenty-one (21) parking spaces in the parking lot at Montgomery Waller Park would be closed for public use from 8 AM until 5 PM on June 10, 2023.

There would be no road closures associated with this event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
