NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – 2-day Music Festival

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Waterfront Park at 1600 Pacific Highway

PROJECT DESCRIPTION: Special Event Permit for temporary lane, sidewalk, and road closures within San Diego public right-of-way jurisdiction that would be associated with the 2-day Music Festival, a concert performance event that would occur at the County of San Diego Waterfront Park at the Embarcadero on June 17-18, 2023. The event permit would be issued by the County. Noise associated with the event activities and set-up/ dismantling would occur from 12 AM on June 15, 2023, until 11 PM on June 19, 2023. There would be a stage with entertainment and sound amplification would occur from 9 AM until 10:30 PM on June 17 and 18, 2023. There would also be a drone flying the Waterfront Park property line. Set-up would occur from 12 AM until 11 PM on June 15 and 16, 2023. The event would occur from 2 PM until 10:30 PM on June 17 and 18, 2023. And dismantling would occur from 12:10 AM until 11 PM on June 19, 2023.

Lane, parking, and sidewalk closures within the City's jurisdiction would include Frontage Road between Grape and Hawthorn from 12:01 AM on June 15, 2023, until 11:55 PM on June 19, 2023; N. Harbor Drive (parking and street closure) between W. Ash Street and Grape Street from 12 AM on June 15, 2023, until 11 PM on June 19, 2023; Public parking closures would include Grape Street (Waterfront Park side (5) spots) between N. Harbor Drive and Pacific Highway, and N. Harbor Drive and Hawthorn Street (Frontage Road Parking (20 spots)) from 12 PM on June 15, 2023 until 11:55 PM on June 19, 2023. See map attached.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
