## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Black Mountain Trail Races
COMMUNITY PLAN AREA: Rancho Penasquitos
COUNCIL DISTRICT: 5
LOCATION: Trails throughout Black Mountain Open Space Regional Park, Hilltop Park

**PROJECT DESCRIPTION:** Special Event Permit for a 50K, 25K, and half marathon trail run throughout Black Mountain Open Regional Park, on June 17, 2023, see attached map. The start and finish would take place at Hilltop Community Park. In addition to the running trails, the event would include a truss at the finish line, sound amplification, music, generators, portable toilets, tents, and recycling and trash containers. Noise associated with the event including set-up and dismantling would occur from 5 AM until 5 PM to June 17, 2023. Set-up would occur from 8 AM to 4 PM on June 16, 2023, and from 5:30 AM to 6:30 AM on June 17, 2023. The event would occur on June 17, 2023, from 6:30 AM to 4:30 PM, and dismantling would occur from 4:30 PM to 5 PM on June 17, 2023, and from 8 AM until 10 AM on June 18, 2023. The total estimated attendees would be approximately 250.

There would be no road closures associated with this event.

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
