NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – ArtWalk Summer Series - Little Italy
COMMUNITY PLAN AREA: Downtown
COUNCIL DISTRICT: 3
LOCATION: Date Street between Columbia Street and Kettner Boulevard, 550 W. Date Street

PROJECT DESCRIPTION: Special Event Permit for an art market that would include the temporary use of vendors, entertainment, and tents that would occur on Date Street between Columbia Street and Kettner Boulevard on Sundays in 2023 on the following dates: June 25 and July 23. Noise associated with the event activities and set-up/dismantling would occur from 7 AM until 7 PM on each Sunday listed above. For the two dates listed above, set-up would occur from 7 AM until 11 AM, the market would be open from 11 AM until 5 PM, and clean-up/dismantling would occur from 5 PM until 7 PM.

A road and parking closure would be associated with the event and would include W. Date Street between India Street and Kettner Boulevard from 6:30 AM until 7 PM for each date listed above.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
