NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – She Fest 2023
COMMUNITY PLAN AREA: Uptown
COUNCIL DISTRICT: 3
LOCATION: Normal Street between University and Lincoln Avenues and on Harvey Milk Street between Normal Street and Cleveland Ave

PROJECT DESCRIPTION:

Special Event Permit for an event on July 8, 2023 that would occur on Normal Street between University and Lincoln Avenues and on Harvey Milk Street between Normal Street and Cleveland Ave. The event would include the temporary use of live music, activities, workshops, vendors, onsite food preparation, sound amplification, food trucks, a stage, entertainment, generator, fencing and/or barrier, portable restrooms, canopies, recycling and trash containers, tables, and chairs. Noise associated with the event activities and setup/dismantling would occur from 8AM until 8 PM on July 8, 2023. Set-up for the event would occur on July 8, 2023 from 8 AM until 12 PM, the event would occur from 12 PM until 6 PM, and dismantling would occur from 6 PM until 8 PM.

Road closures would be associated with this event and would occur from 8 AM until 8 PM on July 8, 2023, on Normal Street between University Avenue and Lincoln Avenues and on Harvey Milk Street between Normal Street and Cleveland Avenue.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
