## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Bleached Festival COMMUNITY PLAN AREA: Downtown COUNCIL DISTRICT: 3 LOCATION: Waterfront Park (see attached)

**PROJECT DESCRIPTION:** Special Event Permit for the removal of parking for a County of San Diego event (Bleached Festival) that would consist of music, beer garden and food and entertainment. The event would occur on August 5 & 6, 2023 from 12 PM to 11 PM and 12 PM to 10 PM respectively. Noise associated with the event would occur from July 31, 2023 through August 8, 2023. Set up would occur over seven days; July 31, 2023 from 5 PM to 11 PM, August 1-5, 2023 from 6 AM to 11 PM and August 6, 2023 from 6 AM to 12 PM. Dismantling would occur on August 7, 2023 from 6 AM to 10 PM and August 8, 2023 from 6 AM to 8 AM.

Parking would be removed from August 1, 2023 at 6 AM on August 7, 2023 at 8 PM in the small parking lot adjacent (west) to Solar Turbine lot between W. Hawthorne and W. Grape Street and along Pacific Coast Highway from Grape Street to Ash Street. Parking would be removed from August 1, 2023 at 6 AM to August 8, 2023 at 8 AM along Harbor Drive from Ash Street to Grape Street. Parking would also be removed from July 31, 2023 at 8 AM to August 7, 2023 at 8 PM on the south side of Grape Street from Harbor Drive to Pacific Coast Highway. The sidewalk would also be closed along the Waterfront Park on Harbor Drive and portions of Grape Street (see attached).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.



You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
