## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Estrella Block Party
COMMUNITY PLAN AREA: Downtown
COUNCIL DISTRICT: 3
LOCATION: 5<sup>th</sup> Avenue between J St and L Street and K Street from 4<sup>th</sup> Ave to 6<sup>th</sup> Ave (see attached map)

**PROJECT DESCRIPTION:** Special Event Permit to allow a concert/block party on August 25, 2023 on 5<sup>th</sup> Avenue between J and L Streets and K Street from 4<sup>th</sup> Ave to 6<sup>th</sup>Ave. The event would include live entertainment, performances, music, a stage, alcohol, fencing and/or barriers, food, games, lighting, portable restrooms, generators, canopies, tables and chairs, and sound amplification from 6 PM to 11 PM with a sound check at 3 PM. Noise associated with the event would occur from 8 AM on August 24, 2023 to 6 AM on August 26, 2023. Set up would occur on August 24, 2023 from 8 AM to 11 AM and on August 25, 2023 from 3 AM to 6 PM, the event would occur from 6 PM to 11:30 PM and dismantling would occur from 11:30 PM through the next day on August 26, 2023 at 6 AM.

Road closures would occur at 3:00 a.m. on August 25, 2023 and will be re-opened at 6:00 a.m. on August 26, 2023 and would include 5<sup>th</sup> Ave between J St and L Street and and on K St between 4<sup>th</sup> Ave to 6<sup>th</sup> Ave.

## ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
