NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit- St. Patrick's Fall Festival

COMMUNITY PLAN AREA: North Park

COUNCIL DISTRICT: 3 **LOCATION:** 3014 Capps St.

PROJECT DESCRIPTION: Special Event Permit for the St. Patrick's Fall Festival at 3014 Capps St on October 14, 2023. The event would include food, interactive booths and games, entertainment, dance performances, beer garden, fencing and/or barriers, vendors, electrical sources for power, inflatable obstacle course, jumpers and slides, and portable restrooms. Noise associated with the event would occur on October 14, 2023 from 7 AM to October 15, 2023 at 9 PM. Set up would occur over two days; October 14, 2023 from 7 AM to 11:30 AM and on October 15, 2023 from 7 AM to 10:30 AM, the event would also occur over two days; on October 14, 2023 from 12 PM to 6 PM and on October 15, 2023 from 11 AM to 5 PM. Dismantling would occur on October 15, 2023 from 5:15 PM to 9 PM.

Capps Street from Ray Street to 30th Street would be closed on October 14, 2023 at 7 AM through October 15, 2023 at 9 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
