NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit- ICAP- October 16, 2023

COMMUNITY PLAN AREA: Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** 5th Ave between Market St and L St and on Island St, J St and K St between 4th and 6th Ave

PROJECT DESCRIPTION: Special Event Permit for a private block party that would occur on 6th Ave between Market St and L St and on Island St, J St and K St between 4th and 5th Ave on October 15, 2023. The event would include two stages, entertainment, sound amplification, generators, alcohol, fencing and/or barriers, food, canopies, tables, chairs. games, booths, portable restrooms, décor lighting, recycling and trash containers. Noise associated with the event would occur on October 16, 2023 from 3 AM to October 17, 2023 at 8 AM. Set up would occur on October 16, 2023 from 3 AM to October 17, 2023 at 8 AM. Set up would occur on October 16, 2023 from 3 AM to 6:30 PM, the event would occur from 6:30 PM to 10:30 PM, and dismantling would occur from 10:30 PM to 12 AM and from 12 AM to 8 AM on October 17, 2023.

Road closures associated with the event from October 16, 2023 at 3 AM to 8 AM October 17, 2023 and would include 5th Ave between Market St and L St and on Island St, J St and K St between 4th and 6th Ave.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
