NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit- Tierransanta Monster Mash 5K

COMMUNITY PLAN AREA: Tierransanta COUNCIL DISTRICT: 7 LOCATION: Tierrasanta Recreation Center and Community Park, Clairemont Mesa Blvd from Promesa Court to Santo Road (see attached map)

PROJECT DESCRIPTION: A Special Event Permit for the Tierransanta Monster Mash 5K on October 28, 2023 (see attached map). The event would include the run route along Clairemont Mesa Blvd (see map), sound amplification, generators, alcohol, fencing and/or barriers, canopies, food, animals (walking and parade), children's activities, bounce house, costume contest and recycling and trash containers. Noise associated with the event would occur from October 27, 2023 at 4 PM to October 28, 2023 at 2 PM. Set up would occur on October 27, 2023 from 4 PM to 8 PM, the event would occur on October 28, 2023 from 6:30 AM to 12 PM and dismantling would occur from 11:30 AM to 2 PM on October 28, 2023.

A partial road closure would occur on October 28, 2023 from 7:45 AM to 10:30 PM and would include the westbound lane of Clairemont Mesa Blvd from Promesa Court to Santo Road.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
