NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit- San Diego Fall Classic

COMMUNITY PLAN AREA: Mission Bay Park

COUNCIL DISTRICT: 2

LOCATION: Crown Point Park within Mission Bay Park

PROJECT DESCRIPTION: Special Event Permit for a crew racing event that would include crew racing, vendors, food booths, food trucks, food preparation, tents, and the temporary use of portable restrooms, trash and recycling containers that would occur at Crown Point Park and within Mission Bay on November 12, 2023. Noise associated with the event activities and set-up/dismantling would occur from 12 PM on November 10, 2023, until 10 AM on November 13, 2022. Set-up would occur from 12 PM on November 10, 2023, until 6 AM on November 12, 2023. On November 12, 2023, the event would occur from 6 AM until 1 PM. Dismantling would occur from 1 PM on November 12, 2023, until 10 AM on November 13, 2023. Approximately 3,000 attendees would be anticipated during the course of the event which would occur on November 12, 2023.

There would be no road closures associated with this event.

The Crown Point parking lot would be closed to the public from 4 AM until 2 PM on November 12, 2023.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
