# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit- San Diego Veterans Day Parade

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT:** 3

**LOCATION:** W Grape & N Harbor Drive

**PROJECT DESCRIPTION:** Special Event Permit for that portion within the City's right-of-way jurisdiction of the annual Veterans' Day Parade that would include marching veterans' organizations, military units, civic organizations, bands, floats, a stage, bleachers, portable restrooms, trash/recycling containers, and youth organizations that would occur along Harbor Drive on November 12, 2023. Noise associated with the event activities and set-up/ dismantling would occur from 6 AM until 5 PM on November 12, 2023. Set-up would occur from 6 AM until 10:30 AM, the event would occur from 11 AM until 12:30 PM, and dismantling would occur from 12:30 PM until 5 PM on November 12, 2023. The expected number of attendees would be approximately 5000.

Road closures would be associated with the event and would include N Harbor Drive between Grape and Pacific Highway, and Pacific Highway between Harbor and Broadway, from 6 AM until 1 PM on November 12, 2023. Parking closures would occur on N Harbor Drive between W Ash and W Grape from 12 AM until 3 PM on November 12, 2023. Ash Street would have limited access to the County Administration Building and no parking from 6 AM until 1 PM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory

Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**October 30, 2023**). Appeals to the City Clerk must be filed via email or in-person as follows:

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
