# NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## SPECIAL EVENTS DEPARTMENT

**PROJECT NAME:** Special Event Permit- 2023 Susan G. Komen San Diego 3-Day

**COMMUNITY PLAN AREA:** Mission Bay Park, Torrey Pines, University City, La Jolla, Mission Beach, Ocean Beach, Pacific Beach, Peninsula, Old Town, Uptown, Downtown, citywide roadways

**COUNCIL DISTRICT:** 1, 2, and 3

**LOCATION:** Crown Point Park, Kellogg Park, Sunset Point Park, OB Dog Beach, Bonita Cove, Fanuel St. Park, South Shores Parking Lot, roads throughout the City (see attached maps)

**PROJECT DESCRIPTION:** Special Event Permit for that portion of the 2023 Susan G. Komen San Diego 3-Day event that would occur within the City of San Diego's jurisdiction from November 17-19, 2023. The event would include the run routes (see attached maps), vendors, onsite food preparation, tables, chairs, canopies, a stage, generators, sound amplification, music, and entertainment/performances, portable restrooms, and recycle and trash containers. Noise associated with the event activities and set-up/dismantling would occur from 4 AM on November 13, 2023, until 4 PM on November 20, 2023. Set-up would occur over the course of four days; November 13, 2023, from 4 AM to 10 PM; and from November 14-16, 2023, on each day from 7 AM to 7 PM. The event would occur over the course of three days: November 17-18, 2023, from 7 AM to 8 PM, and on November 19, 2023, from 7 AM to 5 PM. Dismantling would occur on November 19-20, 2023, from 9 AM to 9 PM. Portions of the route, including some parking spaces, would be used for pit stops, cheering sections, and/or lunch and would include Crown Point Shores, Bonita Cove, Kellogg Park, Sunset Point park, Ocean Beach (dog beach south), Fanuel Street Park, South Mission Beach, South Shore Parking Lot.

Participants would obey the rules of the road along the walking route, and no road closures would occur along the route.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

On October 16, 2023, the City of San Diego made the above-referenced environmental determination pursuant to the California Environmental Quality Act (CEQA). This determination is appealable to the City Council. If you have any questions about this determination, contact the City Contact listed above.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**October 30, 2023**). Appeals to the City Clerk must be filed via email or in-person as follows:

1. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2. Appeals filed In-Person: The Environmental Determination Appeal Application Form [DS-3031](#) can be obtained at: <https://www.sandiego.gov/sites/default/files/legacy/developmentservices/pdf/industry/forms/ds3031.pdf>. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

The appeal application can also be obtained from the City Clerk, 202 'C' Street, 1<sup>st</sup> Floor Lobby, San Diego, CA 92101. This information will be made available in alternative formats upon request.

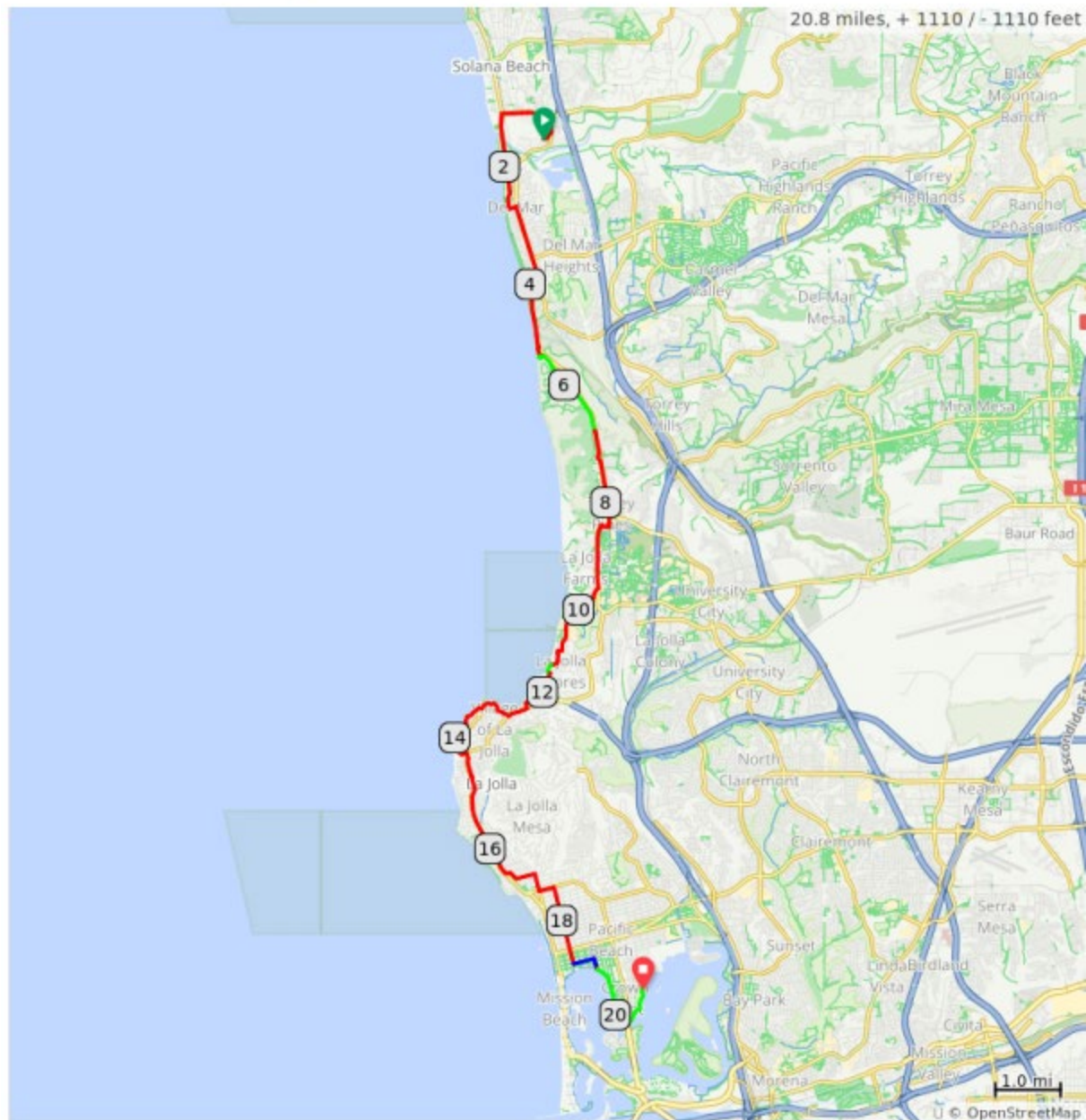

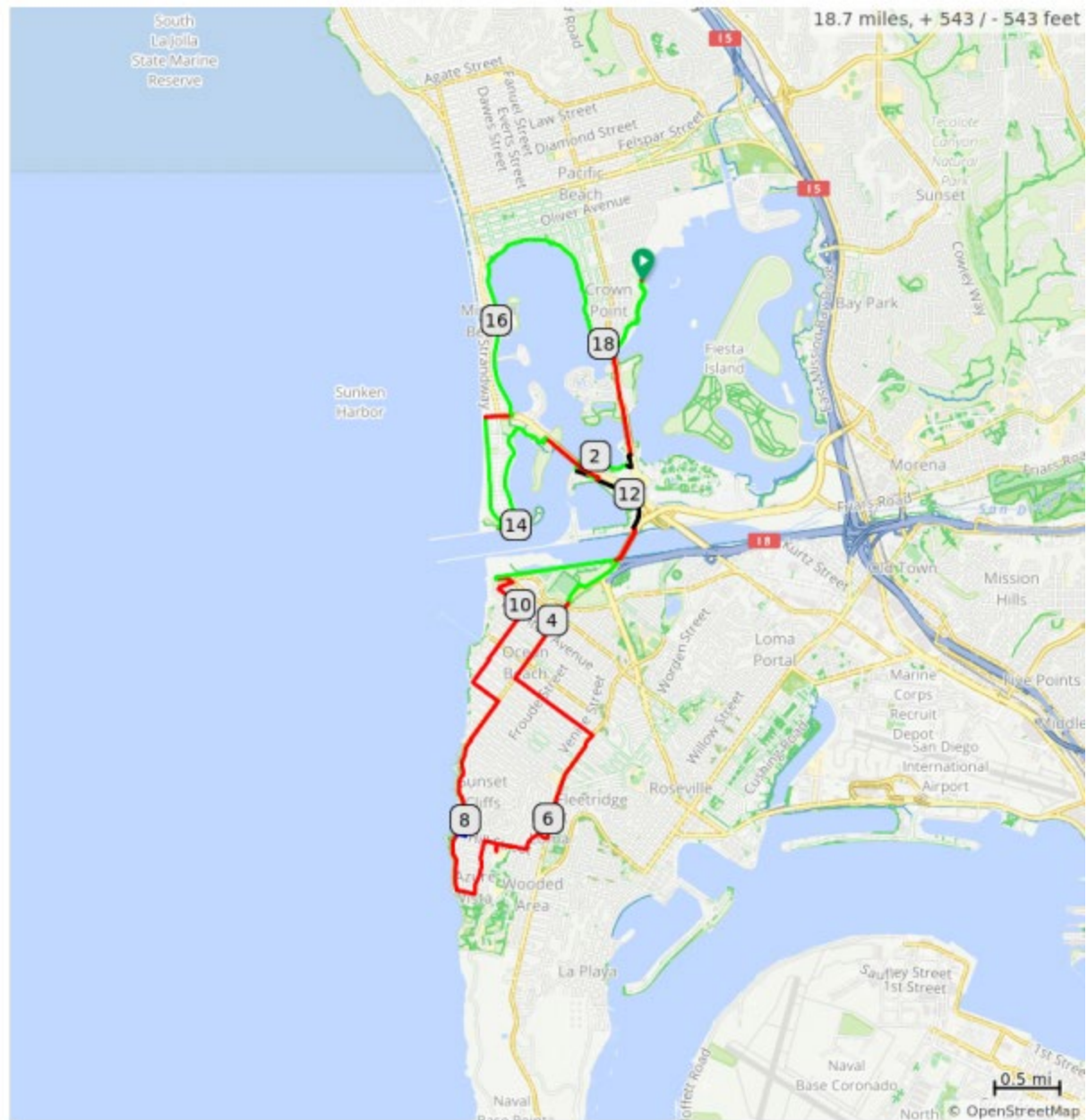
