Gentlemen:

At the regular monthly meeting of the Board of Directors of the Pacific Beach Town Council, Incorporated, the following Resolution was approved:

WHEREAS, the Pacific Beach Town Council recognizes that the sport of surfing is an accepted healthy activity with a right to be enjoyed by enthusiasts in this sport; and

WHEREAS, an ordinance exists which establishes areas of beach use for surfers and swimmers wherein the safety of these activities are provided for; and

WHEREAS, by moving the surfing area further south toward Garnet Avenue pier would create additional hazard to the surfers due to prevailing tide flow twoard said pier, which could easily sweep the surfers into the pilings of said pier and into the fishing lines from said pier;

THEREFORE, BE IT RESOLVED that the Pacific Beach Town Council petition the City of San Diego to make no change in the aforesaid ordinance, and under the provisions thereof, to authorize the establishment of sufficient lifeguard service at the present designated areas to properly supervise and maintain order; and

BE IT RESOLVED that the City Council of San Diego be requested to establish adequate access roads to the areas allocated for surfing purposes, together with parking facilities, and that suitable dressing room facilities be constructed to serve these areas; and

BE IT RESOLVED that the Pacific Beach Town Council request a program of education to be instituted by City authorities to acquaint the public as to its rights, privileges and responsibilities in regard to the proper use of beach areas allocated to surfboard, swimming, and picnicking activities without detriment to adjoining properties; and

BE IT RESOLVED that the Pacific Beach Town Council take interest and urge service organizations in the community to also take interest that all concerned, through their appointed committees, support and supplement said program for the greater enhancement and enjoyment of the beaches in this community; and

BE IT FURTHER RESOLVED to forward copy of this Resolution to the Department of Parks and Recreation, Aquatic Division, for its information and action
