In accordance with Public Utilities Code section 132354.7 and Public Contract Code sections 2600-2602, Flatiron West, Inc. (the "Prime Contractor") certifies that all the Prime Contractor's workers performing work in an apprenticeable occupation utilized on the project known as Morena Pump Station during this monthly reporting period are either skilled journeypersons or apprentices registered in an apprenticeship program approved by the Chief of the Division of Apprenticeship Standards of the California Department of Industrial Relations (the "Chief").

In addition, the Prime Contractor certifies that it has met the requirements of Public Contract Code 2601(d), subject to certain exceptions set forth therein, that the required percentage of the skilled journeypersons or skilled journeyperson hours employed to perform work on the Project by the Prime Contractor are graduates of an apprenticeship program for the applicable apprenticeable occupation¹.


A graduate of an apprenticeship program means either of the following:

Project: Morena Pump Station – Flatiron Job #3222

Flatiron's findings regarding the Skilled and Trained Workforce:

- Ward and Burke, our tunneling subcontractor, broke a live 15-inch sewer line while sinking a concrete reception shaft. As a result of the break, a sink hole began to develop under an existing roadway (Custer Street) and the upstream sewer began to back up which would have resulted in third party property and environmental damages and fines, notwithstanding unwanted publicity.
- The break was first noticed late in the afternoon of Tuesday, August 9th. Flatiron had no scheduled underground crews on-site to respond, and as a result reached out to both Kenny Homan and Mike Strachota to mobilize a repair crew ASAP. In the meantime, we also reached out to Badger Potholing for the rental of one or two of their Vac trucks in order to stabilize and relieve the incoming sewage flows. Badger was unavailable, so we reached out to the first available Vac truck operator who was not signed up with the project PLA, OCIP or Skilled and Trained requirements. Due to the urgency of the situation, there was no time to vet either the workforce or the subcontractors/vendors that participated in the emergency response.
- On August 10th or 11th, Ray Bluff, Flatiron Project Manager had contacted Mandy at Parsons and informed her of the fact that Flatiron had encountered an emergency situation involving a broken live sewer pipeline and that our response involved the mobilization of additional labor and subcontractor resources that were available immediately to respond to the situation. Ray further explained that he was expecting that we would have discrepancies with regards to our skilled and trained workforce ratios. Mandy informed Ray that she understood and that “these things happen” and felt that there would be no adverse fall-out considering the situation as long as we explained it within our reports. Mandy did, however, inform Ray that we need to have both NU-Line and Nor Cal (Vac Truck Vendors) would need to attend a PLA Pre-Job Conference.
- Both NU-Line and Nor Cal attended the PLA training on Friday, August 26th. The final PLA Pre-Job conference form was sent on Monday, September 5th.
- Neither NU Line nor Nor Cal will be participating on any future contract work here at Morena.

- Due to the immediate need for Flatiron personnel available to resolve the emergency situation on August 9th, Matthew Loustalet was on site without sufficient hours to qualify to be on the Morena Pump Station project. As of September 3, 2022, Mr. Loustalet has roughly 4,400 total hours with the Operating Engineers which is 1,583 hours short of being a skilled employee.

Flatiron's plan to achieve the required goal going forward:

- We do not anticipate another emergency like this happening, therefore we do not have a future goal for this plan to achieve. Flatiron has multiple procedures in place to make sure that individuals who do not qualify as skilled or trained (such as Mr. Loustalet) do not work on the Morena Pump Station project. Since the lapse on August 9th was due to exigent circumstances and not to any failure of those procedures, we will continue following those procedures to maintain compliance.


