- V. CURRENT COMMITTEE PRIORITIES (10 mins)
 - A. Community Events:
 - The CRB Work Plan & Bylaws advises that all CRB Members must participate in community events. As a Committee, we need to keep the Board informed of all events.
 - The Outreach Chair wants to maximize impact of CRB by having representation at largely attended events.

- Ongoing Meetings (e.g., CAST, Pillars of the Community)
 - The Outreach Chair hopes for consistent participation by one or more members to bring awareness about the CRB and to advise the CRB on community activities.
 - Chair wants to organize and have regular attendance at these meetings
- · Ad-Hoc Events (e.g., Better A Block, MLK celebrations)
 - The Outreach Chair wants to organize and have CRB attendance at these meetings.
- · Quarterly Town Halls Sponsored by the CRB
 - The Outreach Chair wants to keep this potential option open for the CRB once the Committee determines there are not existing avenues to achieve similar results (educating the communities about the CRB).
- Community-based and Neighborhood Councils
 - The Outreach Chair wants to organize and have CRB attendance at these meetings.
 - Board and public input will be sought at CRB Open Meetings on possible organizations for CRB outreach.
 - Ernestine suggested the Committee consider having a presence at church meetings.
 - Committee member Bonnie Kenk suggested that one of the Committee members attend her Post Grand Jurors Association Lunch to present on the CRB. She will notify the Outreach Chair and the Executive Director of the meeting date/time/location.
- Youth Outreach
 - The Outreach Chair hopes that we can expand on this area.
 - It was mentioned that CRB member Ramon Montano expressed interest in youth and the CRB. Executive Director Moseley will follow-up with Mr. Montano regarding his interest.

B. SDPD Events

- The Outreach Chair requested a 3-minute script from Taura Gentry. This script will be used by the members to educate the community on the CRB and complaint process. Ms. Gentry agreed to provide the script to the Committee.

- Ms. Gentry suggested that the Outreach Chair work with SDPD's Community Relations Officers (CROs) and LTs at each SDPD Division (9) and ask for their list of events.

- Executive Director Moseley contacted Chief's Office and received the list of CROs for each division. The list was forwarded to the Outreach Chair. The Outreach Chair will ask for volunteers for each division at the CRB's Open Meeting.
