PUBLIC ART COMMITTEE RECOMMENDATION:

Recommend that the Executive Director of the Commission for Arts and Culture approve the temporary exhibit titled *Los Trompos* consisting of an exhibit of artwork by artist Héctor Esrawe for temporary exhibit in Children's Museum Park.

SUMMARY:

City staff has received a temporary exhibit application for an exhibit from the New Children's Museum (Applicant). The Applicant is proposing an exhibit of artwork by Mexico City-based artist Héctor Esrawe. The artwork consists of six varying styles of spinning sculptures with nylon straps that create a webbing support system over steel frames allowing visitors to sit and stand on the structures while they spin. The exhibition is proposed for Children's Museum Park and the sculptures will be distributed throughout the turf area of the park. City staff evaluated the application utilizing criteria contained in the City of San Diego Commission for Arts and Culture Department Instruction – Collection Management Policy for the Civic Art Collection. The results of staff's analysis include:

RE: ARTWORK CRITERIA

<u>Public Safety:</u> If the exhibit is installed and maintained properly within the proposed location of the park (i.e. City approved methods and materials safe for the public) it is unlikely to pose hazards or threats to public safety or public health and/or is unlikely to pose a potential liability for the City in any other way.

<u>Cost:</u> The Applicant would be solely responsible for funding the exhibit. This includes, but is not limited to, insurance, permitting, site preparation, transportation, installation, maintenance, repair, restoration, conservation, deinstallation, removal, site restoration and clean-up.

<u>Availability of Resources:</u> City staff is available to provide administrative services to the Applicant to process the application and execute a temporary exhibit of artwork maintenance and removal agreement.

Relevance: The exhibit would provide an aesthetic and cultural experience for residents and visitors to the Convention Center/Harbor Drive/Marina area of Downtown and the New Children's Museum and activate and enhance the area surrounding the Children's Museum Park, as well as balancing urbanization and development with humanizing elements. The exhibit may stimulate discussion and the exchange of ideas about art and the neighborhood due to the highly visible location. Héctor Esrawe is a Mexico City-based contemporary artist whose work in the public realm is internationally recognized.

<u>Excellence</u>: The proposed exhibit exemplifies artistic merit and quality of workmanship.

<u>Significance:</u> The artwork is important to the artist's overall body of work as a traveling solo exhibition.

Condition: Not applicable.

<u>Maintenance</u>: The Applicant will be responsible for maintenance, conservation, restoration, and repair of the exhibit for the duration of the exhibit period.

<u>Security:</u> The City is patrolled by the San Diego Police Department. The site is adjacent to the New Children's Museum and the Applicant has indicated that Museum staff will regularly monitor the site. The applicant has indicated that custom covers will be installed over the artwork elements during the nighttime hours.

Relationship to Site: The exhibit is to be sited in the center of the triangular turf area of Children's Museum Park south of W Island Street and the main entrance of the New Children's Museum building. The exhibit will serve to activate the area for both park and museum visitors.

<u>Legal and Ethical Considerations:</u> If the exhibit is authorized, it will be formalized in a temporary exhibit of artwork maintenance and removal agreement between the Applicant and the City. The artist has provided a royalty-free license to reproduce images of the artwork for non-commercial purposes and waiver of rights conferred under the Visual Artists Rights Act and California Art Preservation Act.

<u>Timing:</u> If the exhibit is authorized, the Applicant will be responsible for proposing a date for exhibit installation and commencing work in compliance with the agreement between the Applicant and the City. The exhibit is proposed to be on view from mid-September 2022 to late-January 2023.

<u>Selection Process for the Artist:</u> The Applicant has indicated that the artist was chosen based on a long-term curatorial research process and from a shortlist of potential commissions. The Applicant has indicated that the criteria for the artist's selection were based on previous work in the public realm, as well as conceptual interests that reflect the diversity of San Diego county.

<u>Community Feedback:</u> The Applicant has indicated that they are in regular communication with the management of nearby residential buildings and previous exhibits in the park have been well received.

Restrictions: Not applicable.

<u>Commemorative Significance:</u> Not applicable.

<u>Fair Exchange:</u> Not applicable.

Fair Purchase Price: Not applicable.

RE: SITE SELECTION CRITERIA

Ownership: Children's Museum Park is owned by the City.

<u>Public Safety:</u> If the exhibit is installed an maintained properly within the proposed location of the park (i.e. City approved methods and materials safe for the public) it is unlikely to pose hazards or threats to public safety or public health and/or are unlikely to pose a potential liability for the City in any other way. The Applicant would be required to enter into an agreement with the City to install and maintain the artwork on City property.

<u>Security:</u> The City is patrolled by the San Diego Police Department. The site is adjacent to the New Children's Museum and the Applicant has indicated that Museum staff will regularly monitor the site.

<u>Maintenance:</u> Parks are managed by the City's Parks and Recreation Department; however, Children's Museum Park is maintained by the Applicant through a maintenance agreement with the City.

<u>Accessibility:</u> Children's Museum Park is accessible, and the exhibit provides for multiple modes of engagement.

<u>Context:</u> The exhibit is to be sited in the center of the triangular turf area of Children's Museum Park south of W Island Street and the main entrance of the New Children's Museum building. The exhibit will serve to activate the area for both park and museum visitors.

<u>Support of City Departments:</u> Staff consulted with relevant City departments to confirm eligibility for the proposed site and will route the exhibit proposal with the analysis and recommendation from the Commission to relevant City departments for any additional feedback and recommendations about the proposal.

<u>Community Support:</u> The Applicant has indicated that they are in regular communication with the management of nearby residential buildings and previous exhibits in the park have been well received.

Adherence to Relevant Plans: The City adheres to existing community plans and land use plans, such as the City's General Plan.

On July 1, 2022, the Public Art Committee (PAC) evaluated the application utilizing the artwork and site selection criteria contained in the City of San Diego Commission for Arts and Culture Department Instruction – Collection Management Policy for the Civic Art Collection and voted (9-0-0) to recommend to the City of San Diego Commission for Arts and Culture (Commission) that the Executive Director of the Commission approve the temporary exhibit

titled *Los Trompos* consisting of an exhibit of artwork by artist Héctor Esrawe for temporary exhibit in Children's Museum Park.

The Executive Director of the Commission will consider the recommendation from City staff, the Public Art Committee, the Commission, and any other pertinent stakeholders before making the final decision on whether to authorize the proposed exhibit.

FISCAL CONSIDERATIONS:

Should this exhibit be authorized for temporary installation, the Applicant will be responsible for all costs.

Description of exhibition

The exhibition will consist of 6 varying styles of spinning sculptures that are made primarily of steel and nylon straps. They are 8 foot in diameter at their base and are almost 8 feet tall. The nylon straps create a "webbing" or "lawn chair-like" support system over the steel frames that allows people to sit and stand on structure while it spins. The sculptures will be orientated around 12 feet from each other throughout the triangle grass section of our Museum Park. There will be small concrete pads installed to keep sculptures balanced and level on the uneven grass. They weigh up to 1,100 lbs. each and will be attached to their concrete basis so solidify the support. They will also be wrapped with custom made covers outside of museum hours to prevent vandalism and damage.

Description of installation plan with a timeline

Week of September 12th, 2022:

- 6 Sculptures Delivered to NCM (Partly-assembled)
- Fence off park grass area
- Install concrete pads
- Assemble and place sculptures on concrete pads and bolt in place.

Week of January 27th, 2023:

Do install 2 of the Couletures and ship heat to Day Area Discovery Museum

Héctor Esrawe

Héctor Esrawe was born in 1968 in Mexico City. He graduated from the Universidad Iberoamericana (UIA) in 1992 as an Industrial Designer. From 1997-2001 he was a Design Professor at UIA, after that he became Design Director at CENTRO Study House, where he created the Industrial Design Degree. In 2003, he launched his multidisciplinary design practice, Esrawe Studio, which he directs until today.

Esrawe's designs consist of furniture, object and interior design, as well as architecture, public space installation and museography. Hector firmly believes in collaboration and multidisciplinary interaction, which has allowed him to work with other design and architecture studios, urbanists, artists, museum curators and scenographers. This enthusiasm has led him to become a cofounder of **EWE**, **VISSIO** and **MASA**, which aim to promote Mexican collectible design. He is also a founding partner of the perfumery brand **Xinú** and of **Casa del Agua**, which collects rainwater and filters it into alkaline drinkable water.

Esrawe's work has earned him international recognition -he is one of the Top 100 Creatives 2021 by AD Magazine Germany- and awards such as: Interior Design Studio of the Year 2020 by Dezeen Awards. Best of Year, Dezeen Award and Azure Award of Merit 2020 for Tori Tori Santa Fe; Mexico's Best Interior Designer at Firenze Entremuros Award 2019; Best of Year Award 2019 for Grupo Arca's Design Center in Guadalajara; AZ Award 2018 for El Califa Restaurant; Jury Prize and People's Choice in FRAME Awards 2018 for Annual Arca pavilion; Wallpaper Design Award 2018 for Xinú and Interior Practice of the Year in World Interior News 2018, among others. His work is present in the permanent collection of the High Museum of Art in Atlanta, with the Centípede bench and the Vestigios jewelry collection.
