A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REINSTATING GENERAL PLAN
MAINTENANCE FEES FOR ACCESSORY DWELLING
UNITS AND JUNIOR ACCESSORY DWELLING UNITS.

WHEREAS, on July 24, 2017, the City Council approved amendments to the accessory dwelling unit (once called companion units) regulations to comply with the State mandate regarding accessory dwelling units set forth in sections 65852.1 and 65852.2 of the California Government Code; and

WHEREAS, the City Council also approved amendments to include regulations concerning junior accessory dwelling units to conform with section 65852.22 of the California Government Code; and

WHEREAS, the amendments and the State mandate were in response to the State's severe housing crisis and were intended to have the effect of providing the creation of accessory dwelling units; and

WHEREAS, accessory dwelling units and junior accessory dwelling units are intended to provide additional rental housing stock, are an essential component of the housing supply, and provide housing for family members, students, the elderly, in-home health care providers, the disabled, and others, at below market prices within existing neighborhoods; and

WHEREAS, on May 10, 2018, the City Council approved Resolution R-311730 waiving general plan maintenance fees for accessory dwelling units and junior accessory dwelling units; and

WHEREAS, when the City Council adopted a waiver of the general plan maintenance fee for accessory dwelling units and junior accessory dwelling units, the City's regulations largely only anticipated one accessory dwelling unit per residential unit; and

WHEREAS, with the more recent adoption of the City's accessory dwelling unit density bonus program, where many accessory dwelling units can now be constructed on a single lot, the policy behind the fee waiver has evolved; and

WHEREAS, given that the total amount of the general plan maintenance fee waiver is generally nominal and given the flexibility provided for accessory dwelling unit development, the waiver of an otherwise generally applicable fee is no longer appropriate for accessory dwelling units and junior accessory dwelling units; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Council reinstate the general plan maintenance fee for accessory dwelling units (previously referred to as companion units) and junior accessory dwelling units.
2. That this action supersedes the action taken in the approved Resolution R-311730 waiving the general plan maintenance fees for these units.
