Gentlemen:

The undersigned petitioner hereby makes application for a license to operate a restaurant at 4102 Market Street, in the City of San Diego, and respectfully submits the following details of how the restaurant is to be operated and conducted:

Meals and short-orders will be served at popular prices through the day and until late at night; part of the floor space will be used for dancing; musicians and entertainers will be provided, and the guests may dance with each other; there will be employed the necessary number of waitresses, who will be paid a regular guaranteed salary; when these waitresses are not engaged in waiting upon table, they will be permitted to dance and eat with the guests; an officer, preferably a retired San Diego police officer, will be in attendance, and strict order, good behavior and decorum will at all times be insisted upon and observed. It is the intention to run a strictly reputable, law abiding, bonified restaurant with wholesome entertainment, where all classes of the public are to be invited.

Your petitioner respectfully requests that this petition be referred to the proper officer for investigation and recommendation, and that a license and permit be issued for the operating of the said proposed restaurant.



Dear Sir:

Herewith return petition of Mr. Paul F. Arriola for a license to operate a restaurant at 4102 Market Street. After investigating the various ordinances applicable to this application, I find the following to be the facts:

Our Cabaret Ordinance, No. 7761, does not permit any of the entertainers employed by the cabaret to mingle with or associate with the patrons of the cabaret. Under our Dance Hall Ordinance, No. 10243, there are certain regulations relative to the employment of instructors upon the dance floor. The facts contained in Mr. Arriola's petition show that he intends to use the waitresses in their spare moments (if any) to dance with the patrons. Since he is not running a dance hall, such waitresses could not be termed as instructors; and since he is possibly attempting to run a cabaret, the waitresses would not be permitted to dance with the patrons.

In view of the conclusions, it is my opinion  
that Mr. Arriola's petition should be denied.


