### **City files Permit for Annual Point La Jolla Closure**

To protect the public and wildlife, the City applied for a Coastal Development Permit to implement an annual seasonal closure of Point La Jolla from May 25 through September 15.

Thank you to everyone that participated in reflecting on last year's emergency closure and forming a thoughtful plan going forward. This effort was only possible with the input of the Mayor's office, Parks & Recreation Department, San Diego Lifeguards, Sierra Club San Diego, San Diego Waterman's Alliance, La Jolla community groups, and the over 1,500 individuals that completed the public survey. Because of your input, we

were able to achieve a compromise that both preserves beach access and keeps the public at a safe distance to enjoy the natural wildlife on our coastline.

#### **Update of Recent String of Northern Burglaries**

Due to the recent string of organized burglaries in the northern part of District 1, SDPD officers and supervisors have had a heightened presence in our neighborhoods. Officers spoke with over 100 residents since January, and the information provided was very helpful. My office facilitated an informal town hall between the community and SDPD in January, which allowed nearly 150 residents to share their experiences and observations and hear directly from Captain Wahl of Northern Division and his officers.

I am happy to report that there have been no burglaries in the Muirlands neighborhood the past few weeks; nevertheless, the FBI, San Diego County Sheriff, Los Angeles law enforcement, and San Diego Police Department all continue to work on this case.

My office continues to work closely with Captain Wahl and will deliver updates as available. In the meantime, <u>here</u> is a recent article on the crimes affecting the region and may help you better protect your property and valuables.

Thank you to all who reached out – your collaboration and cooperation my office and SDPD helps keep us all safe.

## **District 1 Gets it Done**

New year, and #TeamLaCava hit the ground running! Please see below for a few of our most recent "community wins."

#### **Carmel Valley**

 We joined with the Carmel Valley Community Planning Board in pursuit of city action on their 2016 Livability Subcommittee Report. City Transportation responded and delivered an initial detailed report at the board's January meeting. We will hear more from Transportation in the coming months;

- Three different lights at the Carmel Valley Skate Park replaced, as well as two streetlights on the corner of Harwick Lane and Harwick Place;
- Vehicles from Rancho Toyon Place in Del Mar Mesa removed;
- Trash receptacles at the pedestrian path near Carmel Valley Middle School installed to combat frequent littering;
- Multiple infrastructure projects are nearing final design and set for construction, including:
  - Pacific Highlands Ranch library is planned to begin Summer 2022, with a projected opening in in late 2023 or early 2024 (these are new dates due to a prior bid protect.)
  - El Camino Real Bridge Widening Project is now planned to begin January 2023, with a projected opening in April 2026.
  - Construction to connect the SR56 bike path to the Sorrento Valley Bike/Pedestrian Trail is planned to begin June 2023 with a projected opening in late February 2024.

#### La Jolla

- "No Left Turn" on Little Street at Torrey Pines Road approved;
- \$718,790 in State grant funding to construct a permanent guardrail on Torrey Pines Road between Coast Walk and Prospect Place accepted by City Council;
- New public restrooms and showers at Scripps Park opened. This project has been in discussion since December 2014 and is privately funded, with construction taking place since August 2019. We worked closely with the city, contractor, and the community in timely resolution of issues that arose during construction;
- As part of the 2021 Franchise Agreement a new Memorandum of Understanding with SDG&E for utility undergrounding was approved by City Council. We lost 2020 and 2021 but undergrounding projects will begin again in earnest in 2023. We secured restart of work on three "legacy" projects in La Jolla which will be completed by the end of 2022, with SDG&E removing utility poles in La Jolla Shores east of La Jolla Shores Drive by the end of February;
- Organized town hall meeting with SDPD and nearly 150 Muirlands residents to address the recent burglaries;
- Attended the LJ Community Planning Association, LJ Town Council, and LJ Parks & Beaches meetings, regarding the City's proposed seasonal closure of Point La Jolla;
- Attended the La Jolla Open Aire Market on February 6, listening and engaging with two dozen residents on topics such as public safety, infrastructure, and residential permitting processes. If you missed me, I'll be back at the Market on 6th and, hopefully, every first Sunday;
- Working with neighbors and Code Enforcement, we shut down a party house in Lower Hermosa;
- My community rep personally removed box, plastic, and Styrofoam packing from an 85" television recently dumped along La Jolla Parkway. I am also working with Caltrans to remove debris further east which is within their right-of-way and emphasized the debris often reported in this area.

- Large dumpster was blocking a fire hydrant at the Venetian Condos along Nobel Drive removed; removed;

- · Unsightly utility box at La Jolla Colony Drive removed;
- Dangerous segment of Via Mallorca paved and repaired;
- Despite the redrawing of district boundaries, we continue our support of the University City community.
