# NOTICE OF RIGHT TO APPEAL

**PROJECT NAME:** Asphalt Resurfacing Group 1901 Minorca Addition

**COMMUNITY PLAN AREA:** Torrey Pines Community Planning Area

**LOCATION:** Minorca Way & Minorca Cove

**PROJECT DESCRIPTION:** The project involves furnishing all labor, materials, equipment, services and construction which include placement of asphalt overlay; cold milling; pavement base repair; street and sidewalk sweeping; replacing damaged curb and gutter; replacement and installation of new existing traffic striping, markings/legends, and street signs; storm drain inlet protection; and tree maintenance such as tree root pruning, crown reduction, root barrier installation, and sediment control. All work would occur within and adjacent to the public right-of-way (paved streets) within developed areas.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** This activity is categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15301(c) (Existing Facilities).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project is exempt pursuant to State CEQA Guidelines Section 15301(c) (Existing Facilities) which allows for operation, repair, maintenance activities, minor alterations to existing public or private facilities involving negligible or no expansion of use, including the maintenance of existing streets, sidewalks, gutters, similar facilities; and where the exceptions to the exemptions listed in CEQA Section 15300.2 would not apply.

Applications to appeal CEQA determinations made by staff to the City Council must be filed in the Office of the City Clerk within ten (10) business days from the date of the posting of this Notice (April 14, 2021). Appeal procedures are described in Information Bulletin 505 (<https://www.sandiego.gov/sites/default/files/dsdib505.pdf>). Appeals to the City Clerk must be filed by email or in-person as follows:

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked within 5 business days of the date the appeal is filed.
- 2) Appeals filed in person: The Environmental Determination Appeal Application Form DS-3031 can be obtained at <https://www.sandiego.gov/sites/default/files/legacy/development-services/pdf/industry/forms/ds3031.pdf>. Deposit the fully completed appeal application (including grounds for appeal and supporting documentation) to the City Administration Building—Public Information Counter (Open 8:00 a.m. to 5:00 p.m. Monday through Friday excluding City-approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00 p.m. on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer. Please include the project name on the memo line of the check/money order. This Drop-Off Box is checked daily, and payments are processed the following business day.
