Suggestions for Success

- Arrive at least 15 minutes before start of class (please follow the written directions provided to you and do a test run before the first day of class).
- Wear appropriate clothing (long pants, long-sleeved work clothes, and closed-toe sturdy shoes). You will be doing hands-on training that involves lifting, bending, reaching, pulling, kneeling. You may get dirty.
