- 1. San Diego Police/Community Relations Officer Jenny Hall reported that last month in the Normal Heights Community, there were no residential break ins, 2 vehicle break ins and 2 vehicles stolen. There was also an assault with a deadly weapon at the park with a hand/finger injury and a drunk patron in the park who was contacted by officer. Also, dispatcher communication recording shows that calls are up city wide about 300–1400 per day compared to last year including both non-emergency and emergency calls. Dispatchers are hiring. Lastly, free hot spot for check out circulates for 90 days is now available for those who have a library card.

The Humane Society offered to do tips and tricks for leash handling and managing stress signals for pups and their interactions for pups and owner.

- 1. Kemii Soundara, OCA Center Director Kemii Soundara reported the ending of summer lunch program, Luau for the Movie in the Park showing Lilo and stitch. Fall program is open for registration which includes Zumba, Peewee sports, 10/12u Flag football, Parents' night out and Fall day camp. Also, the removal of 3 old ball field light poles, building is almost done being painted and the marquee updated and running.
- 2. Michele Chicarelli, Area Manager Michele Chicarelli reported the safety issues with the light poles at Adams that needed to be removed. Also, Option C updates include irrigation team coming out to look at the ground surrounding the irrigation and would like to dig out the area to see how close it is to the cement. The concern here is that the gate for the dog park will line with the cement. There was a meeting with the new fence company who took measurements and is now waiting for a quote to be sent over. Contact with support services is still currently pending, there is a shortage of staff, so things are still moving a bit slower in this department, although communication has been made continuously.
