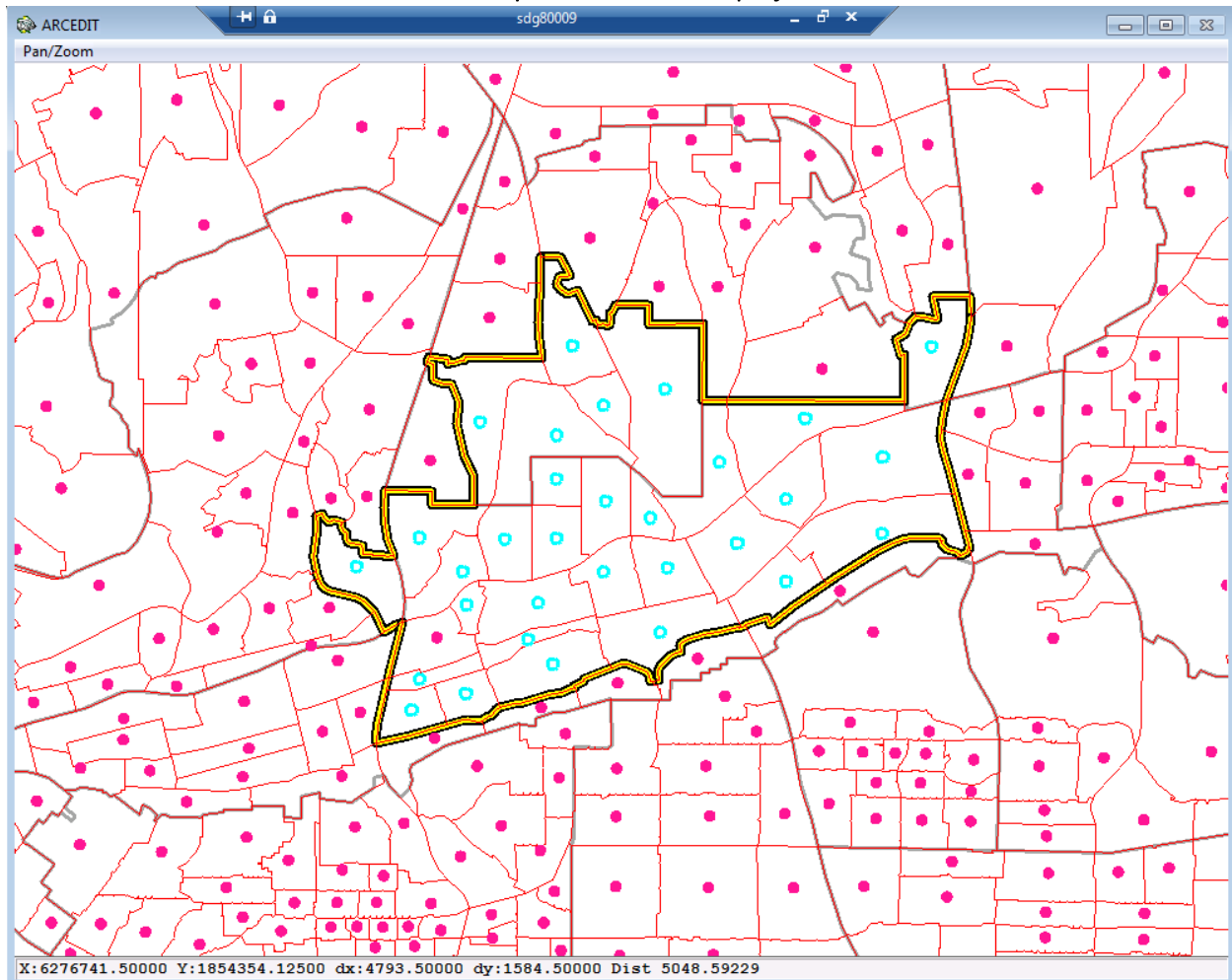
Vehicle Miles Traveled Methodology and Analysis

Section 4.2, Transportation/Circulation and Appendix C provide technical information on transportation model forecasting and detailed traffic operational analyses for the various freeway and roadway segments as well as intersections that would be affected as a result of the proposed project. This appendix includes the modeling results performed by SANDAG for the calculation of VMT within the project influence area.

The project influence area is defined as all Traffic Analysis Zones (TAZ) where the project may cause an increase or decrease of 500 or more average daily trips (ADT). This threshold is consistent with the *City of San Diego Traffic Impact Study Manual, July 1998*. By comparing the SANDAG Series 12 ADT projected for the Year 2035 with Project conditions to the Year 2035 without Project conditions, it was determined that the project influence area would cover the communities of Mission Valley, Serra Mesa, a portion of Linda Vista, and a portion of Kearny Mesa. Figure 1 displays the project influence area.

The VMT analysis was conducted consistent with methodologies discussed in the technical white paper “Vehicle Miles Traveled Calculations Using the SANDAG Regional Travel Demand Model” prepared by the San Diego Institute of Transportation Engineers (ITE)’s Transportation Capacity and Mobility Task Force in May of 2013 (ITE 2013). This methodology disaggregates the VMT within the project influence area into three categories, internal-internal (I/I), internal-external/external-internal (I/E or E/I), and external-external (E/E). Detail description of each category is provided below:

- I/I VMT is associated with trips that have both the origin and destination within the influenced area - 100% of this VMT is included in the final total VMT;
- I/E or E/I VMT is associated with trips that have either an origin or a destination within the influence area - 50% of this VMT is included in the final total VMT;
- E/E VMT is associated with trips that does not have an origin or a destination within the influence area - these are pass-through trips and are not included in the total VMT.

VMT Analysis Results

Based upon methodology described above, a VMT analysis was conducted for all of the study scenarios with and without the proposed project.

Table 1 displays the total VMT generated within the project influence area and the region wide VMT for the following scenarios: Existing Conditions (Year 2013; presented for informational purposes), Near-Term (2017) with and without project, and Long-Term (Year 2035) with and without project scenarios.

As shown, the proposed project would reduce the VMT within the project influence area by 1.8% under both the Near-Term Year 2017 with Connection and the Cumulative Year 2035 with Connection scenarios. The proposed project would also reduce the region wide VMT by .32% under the Near-Term Year 2035 with Connection scenario and by .28% under the Cumulative Year 2035 with Connection scenario.
