ITEM A Project: 325504 – Shtrahman Residence Location: 8558 Sugarman

APN: 346-771-1900

Presented by: Colin Hernstad

### Description:

Proposal for a 754 sf addition and remodel to an existing 2,994 sf single-family dwelling unit on a 10,000 sf lot.

### Presentation

- Project came before the Board approximately 3 years ago
- Owners applied for an extension to the permit, permit eventually expired, and later it was recommended that the owners re-apply to the City to comply with new regulations
- Project will stay single-story, but will add a master suite and roof deck
- Setbacks would remain the same
- Clarification of the roofline provided pitched roof maintained and flat roof over addition area

### Comments

- Concern expressed about future site conditions related to views of neighbors and trees that provide privacy screening
- Concern expressed by the Board about proposed 6-foot walls. Applicant would modify walls to be partially solid (3 feet) and partially transparent (3 feet)

**Motion:** Recommend that the project be processed as a Process 1/Project. Conforms to the La Jolla Shores Planned District Ordinance and that wall be reduced to 4 feet. Donovan/Moser. 4-0-1. Lazerow abstaining due to needing more information about the project.

# Project: PTS 552946 – Brehm/Martin Residence Addition/Remodel Location: 7575 Caminito Avola

APN: 352-680-2900

### Presented by: Bart Smith

### **Description:**

Proposal for a 339 sf addition and remodel to an existing 2,254 sf single-family dwelling unit on a 4,392 sf lot.

### Presentation

- Project proposes no change to the existing roofline
- Existing massing is being retained
- Addition essentially encloses areas with generous overhangs with the removal of several interior posts
- House backs up to a large canyon with views to the La Jolla Cove
- Demolition is currently occurring on site

### Comment

• Concern expressed about articulation of the structure being changed and that articulated facades are characteristic along the street. Applicant responded that articulation would be included through recessed windows, staggered walls, inset garages entries, and landscaping.

**Motion:** Recommend approval of the project as a Process 1. Conforms to the La Jolla Shores Planned District Ordinance as presented. Potter/Donovan. 5-0-0.
