• Description: Kevin Ct Project will be a For Sale Single Family Home project with 23 Homes ocated on Skyline Drive just east of the O'Farrell Charter School. The homes will be 3 and 4 Bedrooms with 2-car attached garage and front/back yards. The street will have access from Skyline Dr. onto a private cul de sac that will be known as Kevin Ct. (in honor of Mr. & Mrs. Robinson's son).

Currently an abandoned home since 2013 on property. Lot sizes will be 2500-3700 sq. ft. Some have decks. There will be three home types. Ito Girard, Neighborhood Estate; EcoHouse Architect. Goal is to finish by end of 2023.

Kevin Court Project Discussion:

Khalada – No price is set yet; it depends on the economy and cost of materials, 20 Market Rate homes; Three homes will be slated as Affordable.

Marry- appreciates options for medium income homes for sale. Faye Pacho Brown agreed/

Anthony Merritt- Concerns about Airbnb's at homes. Will there be an HOA? A- Yes. Can they restrict BnB businesses? It inconveniences residents, and noisy strangers exploit and gentrify the neighborhood. OB has had issues – raises rents & Purchasing issues

Marry-Homes are targeted to Families (Sandra Robinson did outreach). March 2022 Ordinance capped BnBs except in Mission Beach; now requires a Business License and a Lottery System.

Dolvin- Well Done, this is a thoughtful project.

Janet Klauber's son spoke - Party BnB Nuisances

Demetre- Great project.

Rob Campbell – What is the zoning? They look slightly undersize.
