Increasing Access to Healthcare and Healthy Foods Working Group Meeting

Meeting Summary

Organizations Represented

Overview and Summary of July meeting: Co-chairs provided a brief overview of the San Diego Promise Zone (SDPZ) planning process and summarized the July 2017 meeting. The July meeting focused on refining the health indicators and identifying data sources to track progress across the 10 year designation.

Update on Indicators: Co-chair reviewed the updated indicator list and accompanying data sources for all six working groups. The development of the indicators will occur in phases.

- Phase 1: Indicators SDPS will track within the next four to six months.
- Phase 2: Indicators that require integration of multiple data sources. Projected to be tracked within 6 to 9 months.
- Phase 3: Indicators that capture the work of more than one working group and which require further definition and integration of data sources. Timeline for tracking these indicators is not yet determined.
- Phase 4: Indicators which require further definition and identification of data sources before they are considered for development.

Health and Healthy Foods Phase 1 indicators are (1) modified retail food environment index and (2) number people with health insurance. During the meeting, it was shared that HHS will be able to generate a walkability index score every three years beginning October 2017. Thus, the walkability index score will be moved from a Phase 3 to a Phase 1.

Logic Model First Draft: The initial draft of the logic model was reviewed in the meeting. Implementing partners listed on the draft were the primary and larger agencies involved when the application was written. Moving forward, the aim is to reflect the work of partners attending the meeting within the logic model who are working in these areas. The logic model includes content from the initial application, including the committed and needed funding sources for the Health goal area. The group reviewed and discussed the

first sub-goal and its funding sources listed to determine whether they have been awarded, are still in progress, or are no longer a viable source (and thus would need to be replaced).

Sub-goal 1a: Build resident capacity and leadership through the creation of healthy foods choices and accessible food system that can be seen and experienced in a transformed built environment. Reduce rates of chronic disease by leveraging AB551 to grow urban farming.

Committed Support still in place

1. USDA, \$80,000, 10/1/16 to 9/30/19, HHSA to provide public health staff to provide technician assistance to the community in their implementation of this community engagement project

Activities: The group discussed the activities listed under the first sub-goal and discussed ways of collecting that data. The group also brought up ideas about identifying Joint-use Agreements within the zone to track residents' participation in community gardens, as well as identifying farm stands, cooking classes, and commercial kitchen spaces. It was mentioned that this working group should "map out" the work that partners are already doing in the area in regards to the availability and access of healthy foods.

Additional Logic Model SubGoal Areas: At September meeting, the group will continue to review the remaining subgoals. At earlier meetings, the group identified two additional subgoals that they considered important to this working group. During this meeting, the group confirmed their interest and value of Subgoal 1d. However, it was discussed that this subgoal may be crosscutting with other working groups; thus, may be covered in other areas.

Closing: Commit to going over sub-goal 1b and sub-goal 1c in September meeting and monitor whether other groups are addressing subgoal 1d. If not, this group will include in the logic model.

Updates:

- SPDZ Director and VISTAs are developing a fiscal mapping template to be completed by partners and reviewed in subsequent meetings. Fiscal mapping to include guidance for documenting "in-kind" supports.
- **All Partner Meeting**, September 6th, 2-4:30pm at the Jacobs Center for Neighborhood Innovation, 404 Euclid Ave, San Diego, CA. Will be a promise zone overview, collective impact presentation, co-chair reports, HUD updates, refreshments and networking.
