Planned usage:

This area will be divided in two. The area adjacent to Village Place will be controlled for vehicles only (not pedestrians) and it will be utilized for an **Emerging Transportation Technologies Experience**. We expect to profile (fully permitted) self-driving and contemporary fuel vehicles like the newest model electric vehicles. These vehicles may be available to be driven by licensed guests.

The planned usage for the area located to the east of the Natural History Museum:

- **Controlled area:** Maker booths, ticketing and info, retail
