- Provided an update on the solar project for the lower Inspiration Parking lot which will be completed in two phases with a lesser impact on parking

# Susan Lowery-Mendoza, District Manager, Balboa Park Facilities and Special Events, reported the following:

- Repair to bridge overpass at Museum of Man to be completed by Facilities Division in next 30 days (the date is being coordinated with the park) to repair some cosmetic damage caused by an oversized vehicle. The repair is estimated to take 1 – 2 days and the bridge will be closed to vehicular traffic.
- Twilight concerts in the Park begin June 19 in the Organ Pavilion every Tuesday- Thursday throughout the Summer. The schedule is being printed and will be available next week.
- Looking forward to our co-sponsored events this month Cinco de Mayo and Fiesta Botanica on May 26

# Mario Llanos, District Manager, Balboa Park Operations, reported the following:

- Last Month staff led volunteers from Texas Roadhouse at Morley Field and Bird Park for a Volunteer Event that included planting trees and plants, painting, trail maintenance, and weeding...special thanks to The Friends of Balboa Park for coordination of the event. In addition, thank you to The Balboa Park Conservancy and Cal Fire for assisting with the tree planting portion of this project. The Tree Balboa Park project is part of California Climate Investments, a statewide program that puts billions of cap-and-trade dollars to work reducing greenhouse gas emissions, strengthening the economy and improving public health and the environment—particularly in disadvantaged communities. The cap-and-trade program also creates a financial incentive for industries to invest in clean technologies and develop innovative ways to reduce pollution. California Climate Investment projects include affordable housing, renewable energy, public transportation, zero-emission vehicles, environmental restoration, more sustainable agriculture, recycling and much more. At least 35 percent of these investments are made in disadvantaged and low-income communities. For more information, visit California Climate Investments.
- Recently staff planted 33 trees for Arbor Day across from the Zoo Parking lot in partnership with the Friends of Balboa Park. We are at approximately 190 trees planted for the year.
- Today we had a Sugar Gum Eucalyptus removed adjacent to the Casa Del Prado Theatre. The tree was approximately 153 feet high and had a DBH of 63 inches. It is estimated to be approximately 105 years old. The subject tree contained symptoms of *Armillaria mellea*, a decay fungus that causes white rot of the lower trunk and root systems of infected trees. We have been monitoring it and have multiple Arborist reports. Upon removal, our suspicions were confirmed and the center of the truck exhibited significant decay that could have led to failure. Kudos to our two Park Arborists.
