# NON -AGENDA PUBLIC COMMENT

Daniele Laman thanked Andy Field, Interim Director for opening the House of Pacific Relations lawn as scheduled. She noted the theft at Starlight Theater was brought up at the Captain's Advisory and that two active shooter trainings were recently held at the Museum of Art.

#### CHAIRPERSON'S REPORT

Chairperson Johnston noted that the Downtown Community representative seat is vacant if anyone knows of possible candidates.

### STAFF REPORT

City Council Third District – Molly Chase reported the following:

• The fourth bridge shelter is opening today

- Exploring expansion of the Golden Hall shelter
- The Community Action Plan is a client-centered homeless assistance system aimed at preventing homelessness while providing quick paths to affordable housing.
- She asked for input on the budget which is being prepared in January.

Balboa Park Program Manager – Jeff Van Deerlin reported the following:

- The water and sewer group job is slated to begin in January 2020 and he is requesting that SDG&E replace the gas lines simultaneously. The issue involves easement rights that SDG&E is requesting from the City.
- The South Palisades project is moving forward and will be going before City Council for approval which is required by the Municipal Code as labor costs will exceed \$100,000.00.
- The ficus trees in front of the Automotive Museum will be removed by the end of the year as they are damaging the building.
- The seismic retrofit of the California Tower is scheduled to be completed mid-January.

Balboa Park District Manager - Susan Lowery - Mendoza reported the following:

- On Saturday, October 26, Parks and Recreation staff were happy to collaborate once again with the Balboa Park Conservancy at Halloween Family Day. Our staff provides ten fun carnival games, costume contests, raffle with prizes and the opportunity to learn and perform the dance routine to Michael Jackson's Thriller in the Plaza de Panama. It was a fun filled time for all.
- On Saturday November 23, a Celebration of the life of Jared Jacobsen, former Civic Organist will take place at 5:00 p.m. in the Organ Pavilion.
- The December Nights event is less than thirty days away. The event will have many of the same features that it is known for and the community enjoys access to the park's institutions for free. There is one change however to this year's event caused by the delay of the seismic retrofit of the California tower. The Swedish Women's Educational Association activities traditionally held in the California Quadrangle are displaced to other areas of the park and the Museum of Man will be closed. The City's special event team have been meeting and planning for months to have a safe event for all to enjoy.

John Anderson, Senior Park Ranger reported the following:

• Staff are preparing for December Nights, trees are being pruned and the park cleanups underway

#### **Balboa Park Conservancy**

Jackie Higgins shared the following:

- Halloween Family Day seems to grow every year.
- Cal Fire's involvement with the tree inventory, a tree event will take place this Saturday in celebration of Kate Session birthday on the East Mesa picnic area Joe Schloss Way and Jacaranda at 10:00 a.m.
- Working with staff to obtain a Special Use Permit for enhancements to the Casa del Prado
- The Botanical Building project is moving forward and the bridge documents and grant information will be provided to the City in mid-December.
- Read a statement regarding the water and sewer replacement project, impacts to the visitor experience and need for a mitigation plan.

• Regarding the sewer and water line project which was to take place during the Plaza de Panama project, the project was presented with little planning time. An impact mitigation plan is needed and coordination with SDG&E to replace gas lines at the same time.

- Working for years on the rehabilitation of the Automotive Museum provided a tile update
- Concerned about the increasing level of crime in Balboa Park, the presence of police is needed, and we cannot afford to wait.
