BALBOA PARK NON-PROFIT PARTNER UPDATES

Balboa Park Conservancy

Tomás Herrera-Mishler shared the following:

- Thanks to Councilmember Ward, Katherine Johnson and Vicki Granowitz for their leadership on putting this planning process together the scoping of Balboa taking place next month
- Provided updates on the Casa del Prado enhancement project that is privately funded
- Botanical Building project update delivered 60 percent construction drawings to the City and met with many City Departments
- Historic stone walls and trails are being restored in the historic Desert Garden by the California Conservation Corps another privately funded project
- Activations in the Plaza de Panama have drawn 800,000 people to the park and there is a synergy when the cultural institutions participate and collaborate together

Balboa Park Cultural Partnership

Peter Comiskey shared the following:

- The opportunity for the scoping work and the outcome is something the they would like to be involved with.
- It is budget time and Arts and Culture funding is extremely important for the park institutions
- Trustees Connected will occur on Wednesday, March 11, Committee members were asked to save the date
- Smith Leadership Symposium will occur on February 26 at the Comic Con Museum
- Access to Awesome possible to enter and win a year of access to cultural institutions of which there are 50 participating currently

- Working on details of the Firestone fountains

Balboa Park Online Collaborative

Nik Honeysett shared the following:

- Legler Benbough Foundation is sunsetting and was a significant contributor to BPOC. Mr. Honeysett has had to offset their contributions by consulting with Microsoft and museums across the U.S. and the United Kingdom
- WIFI use is used to measure park attendance and has decreased over the past three years
- December Nights Wi-Fi activity was down 20 percent on Friday and 40 percent on Saturday due to the weather
- BPO's Park data center is being moved from the Comic Con Museum
- Kiosk installations in the institutions will gather data

Friends of Balboa Park

John Bolthouse shared the following:

- The footbridge lighting installation is nearly completed between Alcazar Garden and the Organ Pavilion
- Secured funding for the lights in the California Plaza, just waiting for the seismic retrofit of the tower to be completed
- Secured funding for the purchase of a Polaris vehicle for police officers to use in the canyons
- Have secured three quarters of the funding needed for the Morton Bay Fig Tree decking project
- Secured funding for the next landmark interpretive sign the grotto at Golden Hill Park

- Looking forward to the Palisades project and activation of the area

Adoption

201. Patrons of the Prado Proposal for Permanent Recognition Plaque in Balboa Park. Presenters: Charles Daniels, Park Designer, City of San Diego and Micki Olin and Patti Judd, Patrons of the Prado.

Mr. Daniels provided a staff report and requested a recommendation regarding the installation of a commemorative plaque for honorees of the Icon Award; each year a new name would be added to the plaque. The Historic Resources Board Design Assistance Subcommittee and staff have reviewed the plaque and state that it is consistent with preservation standards and recommend alternate site location number two be used which is in the arcade (north side of El Prado, west of the Plaza de Panama). He reviewed the Parks and Recreation Board Policy No. 1002 which is the criteria for evaluating the plaque. Ms. Olin thanked the Committee and provided information about their organization which started in 1997, has raised 4.4 million for the cultural organizations on the Prado in addition to providing funds to bring 200,000 school children to the park. They will take full responsibility for the plaque and continue to work with staff on the design of the plaque.

A motion was made by Ms. Granowitz and seconded by Mr. Davenport to recommend approval of the proposed limited commemorative plaque at the secondary location. The motion carried unanimously (7-0-0).

Chairperson Johnson thanked Ms. Granowitz for all the work she has done on the bylaws. Ms. Granowitz made the requested changes that were suggested at the last meeting and reviewed those changes with the committee. The bylaws will be routed for City approval.

- Design review should be a citywide discussion
- It would be difficult to choose non-members to serve on a subcommittee and to get volunteers
- Lack of training and orientation for members is an issue

Public Comments:

- A design professional should have a permanent role on the Balboa Park Committee
- Allow for the appointment of non- members to subcommittees which allows for a design review by professionals to give advice or recommendations to the Committee
- Recommend seven as the minimum number needed to approve an action instead of six
