Hello Jane,

To follow up on the phone call just now between myself and City staff, after reviewing the jurisdictional maps both here in the Commission office and what you sent me from City records, as well as reviewing the findings of the Master Storm Water Permit A-6-NOC-11-086, we appear to have reached consensus on how best to proceed with formally permitting the emergency work that was conducted by the City in various storm drain channels back in 2010.

Regarding Tripp Court, the past work area falls within the City's permit jurisdiction, non-appealable, and the follow-up permitting would be processed at the City level.

Regarding Sorrento Creek, upon reviewing the staff report for the master storm water permit A-6-NOC-11-086, it appears the past emergency work in that area was known by Commission staff when processing the appeal permit and was discussed in the findings. Thus, because the master permit laid out the required mitigation for impacts arising from work such as what occurred in the 2010 emergency maintenance, the City can draft and submit the necessary documents showing how the impacts from the emergency work were/are going to be mitigated in conformance with the requirements of the master permit. Commission staff will review them for conformity and acceptance afterward.

Regarding Nestor, upon reviewing the original GIS documents from the City showing the location of the past emergency maintenance work and the manner of construction staging and storage, and comparing it to the Commission's jurisdiction maps, it appears the work was conducted in the City's jurisdiction area, appealable to the Commission, so the follow-up permit would be processed at the City level.

I am glad we were able to reach a conclusion on each of the work areas; I will keep an eye out for the above documents once they are processed by the City. Please let me know if you have any questions. Thanks.
