Hello Neighbors!

Here is an update on some of the most prominent pieces of legislation that City Council has passed recently.

First, scooters. On May 14th, City Council followed up its previous unanimous approval of scooter regulations with another 9-0 vote on the legislation's second reading. That means that the new laws regarding scooters will come into effect on July 1st, laws that include geofencing on the boardwalk and bayside walk that will slow scooters to 8 mph. Even with the new rules many of us are disappointed that there is not a scooter ban on our boardwalks. When the Mayor's regulations came to Council, for both the initial hearing and the second reading, I was vocal about my support of banning scooters from the boardwalk. (Page 2)
