



## **Affordable Housing**

For the first time in 22 years, the County and City of San Diego met to discuss and find solutions for the housing shortage in San Diego. At the end of the Housing Summit, the County and the City approved a resolution to add 10,000 affordable housing units on government land by 2030. The resolution will focus on four main topics:

- Streamlining permitting to accelerate housing construction
- Building 10,000 affordable homes on government-owned land near transit lines that also support climate action goals and offer construction workers good-paying jobs
- Leveraging public, private, and other funds to accelerate the availability of affordable housing
- Increase density on properties owned by the San Diego Housing Commission or its nonprofit affiliate

The historic meeting was led by County Supervisor Chair Nathan Fletcher and Council President Sean Elo-Rivera at San Diego State University.

### **Homelessness Solutions**

Homelessness in San Diego is a crisis, and I hear your concerns. I want to assure you that the City's Homelessness Department is working as quickly as possible to help our unsheltered population. One of those solutions includes turning the old Downtown San Diego Library into a shelter. My staff and I recently met with the Mayor's Homelessness Solutions and Strategies Department Director, Hafsa Kaka, who gave us a tour of the facility. In my district, a 34unit shelter on Pacific Highway will open soon. While there is still so much to be done, the Mayor's homelessness programs have increased shelter beds by more than 28% in

### **Reproductive Rights**

The Supreme Court's overturning of Roe v. Wade was a direct attack on people's reproductive rights. In response to this injustice, Senate President Pro Tem Toni Atkins, sponsored the Reproductive Freedom bill, known as Prop 1.

The bill will codify people's freedom and access to reproductive healthcare, including the access to safe abortions, into our State's Constitution.



To show solidarity, I, along with, Councilmember Raul Campillo, authored a City Resolution that supports the "Reproductive Freedom" bill; which passed unanimously at Council. We must do everything we can to protect people's reproductive and sexual healthcare. Because having an abortion or using contraceptives is a fundamental choice between a person and their healthcare providers.

# U.S. Coast Guard Hero

United States Coast Guard Aviation Survival Technician, Joshua Carlson, helped save nine people stranded on a disabled migrant boat on January 2021. Carlson faced 12-foot waves as he swam back and forth from the helicopter to the sinking vessel. Another helicopter crew worked to save an additional 12 people from the vessel.

The Mayor and I presented Carlson with a City Proclamation for his heroic efforts. Carlson, his family, and colleagues joined in the presentation at City Hall.
