We have 2 grants from California's Office of Traffic Safety (OTS) related to pedestrian and bicycle safety. Both of these have grant performance periods from October 2022 – September 2023.

The Selective Traffic Enforcement Program (STEP) grant provides:

- \$72,000 for "Pedestrian and Bicycle Enforcement". We use this money to fund 20 OT details that focus on identifying and contacting violators that put pedestrians and bicyclists at risk. A large majority of the contacts are for drivers operating their vehicles dangerously.
- \$30,600 for "Traffic Safety Education". We use this money to fund 18 OT details that focus on educating the public on pedestrian/bicycle safety. Historically we set up information booths at local farmer's markets to accomplish this.

The Pedestrian and Bicycle Safety Program grant provides \$240,000 to the City for education/outreach related to pedestrian and bicycle safety. This includes classroom education, bicycle rodeos, community events, presentations, and workshops. The City contracts with local non-profit organizations to accomplish this goal, and 100% of the grant money goes to these non-profits. The 2 non-profit organizations currently in place are the San Diego County Bicycle Coalition and Circulate San Diego.

- The Police Department will continue to conduct community outreach as well as enforcement operations related to the STEP grant as well as the Pedestrian and Bicycle Safety Program in the upcoming fiscal year.
- There are no barriers to implementing the CAP actions identified.

- The SDPD has staffed three (3) information booths in the Hillcrest and La Jolla neighborhoods farmers markets. There were a total of 139 community members contacted at these events.
- The SDPD conducted three (3) e-bike presentations in collaboration with the San Diego County Bicycle Coalition and Scripps Health at regional high schools. There were a total of 240 community members contacted at these events.
- The Police Department will continue to conduct similar community outreach, as well as enforcement operations.

• The end goal is to improve safety and encourage more people to walk or cycle to their destinations. This is done by conducting outreach and education throughout the City of San Diego in regards to pedestrian and bicycle safety. A benefit of more people walking and cycling is a decrease of vehicle emissions.

- The Police Department has conducted presentations at local schools in collaboration the San Diego Bicycle Association and Scripps Health to bring safety awareness to the forefront with our local youth. The SDPD has also conducted information booths at the Hillcrest Farmer's Market related to this project.
- The SDPD has conducted outreach in the Hillcrest community, as well as at local schools as it is a priority to keep our youth and communities of concern safe. There is a large volume of pedestrian and bicycle traffic in the Hillcrest community, specifically in the vicinity of 5<sup>th</sup> and University. Because of that, it is a priority to educate the public regarding the dangers related to high volumes of vehicles in that area.
