**Area Manager: Debbie Marcotte**

1. Carmel Valley Recreation Center will be reopening completely in mid-July. We are no longer doing temperature checks and/or screenings. Everyone should self-screen and signage will state if you are fully vaccinated you do not have to wear a mask. No proof of vaccination is required. Reopening hours will be reduced due to limited staff. The site should be open at least for 44 hours a week and no later than 7pm. We only have 2 Recreation Leaders and a Center Director. There is currently no Assistant Center Director.
2. Wendelein from the pool sent over a slide show of the updates. The slides and structure are now painted, and the slides are open.

3. This is Lauren's last week at Carmel Valley. Jerry will be coming back starting Saturday, July 10th.
4. There are many openings in the department including 7 Area Manager openings. There will be a lot of movement within the department.
5. Hopscotch is returning inside the building on July 12 and Rock n' Tumble Gymnastics will return on July 15.
6. Another Movie in the Park is scheduled for August 14. The group discussed getting the information about the movie out sooner. The movie is Honey, I Shrank the Kids.
7. Fall allocations likely will follow the pattern of past years. Requests for adult league field usage on Sundays has been received by our office.

**OCA Recreation Center Director III: Lauren Tufts Mirro**

1. The Movie in the Park event on June 25 went well. There was a half hour delay with the generator and movie screen. The movie was Anastasia. Everyone in attendance seemed be happy to be at an in-person event. The kettle corn was a big hit. There were probably 200 people in attendance.

1. 92130 foundation which formed out of the old Recreation Council had a meeting. The discussion included what to do with the remaining funds and whether to keep the 501c3 going. Some of the ideas included dividing money up among organizations to allow them to do scholarships for programs, one organization being the Recreation Center. The group discussed possibility of donating that money to the "Come Play Outside" program which is funding recreation programs and providing scholarships further south in the city.
2. The arena project was briefly discussed. Nothing new has happened since the meeting with Marilee, Guy, Debbie and the Arena representative. They did a walk of the field and field measurements.
