July 31, 2020: COVID-19 News Update

Dear Neighbors,

My office has received several inquiries from those curious about who benefited from the City's Small Business Relief Fund (SBRF) program during this economic crisis. So, to be as transparent as possible, my staff have compiled some initial statistics on where the aid went, specifically in District 1.

For those unfamiliar with the program, the SBRF launched with an initial \$6.1 million approved by City Council on March 25. On June 9, City Council approved an additional \$12.8 million in Coronavirus Aid, Relief and Economic Security (CARES) Act Funds, pushing the total SBRF funding to over \$20 million, including several million in private donations.

Between the program's official launch on March 27 and its deadline on April 14, 10,232 applications were received. 606 of those applications were from District 1 businesses.

According to the most recent data released by the Economic Development Department, as of July 14, 804 awards were conferred worth \$7.1 million. As of the most recent statistics, 64 applicants from District 1 have received relief.

While I wish this number were higher, scrolling through the beneficiaries, it was nice seeing that some familiar names received some relief.

Here is a breakdown of the funding sources for the entire city:

- \$12.8M CARES Act Fund (grants): 335 businesses awarded (16.9% expended)
- \$3.3M Community Development Block Grants (forgivable loans): 149 businesses awarded (45% expended)
- \$2.17M Revolving Loan Fund (zero-interest loans): 118 businesses awarded (100% expended)
- \$702K Private Donation (grants): 147 businesses awarded (100% expended)
- \$550K Former Enterprise Zone (grants): 55 businesses awarded (100% expended)

My heart goes out to all the entrepreneurs and business owners affected. Whether it's the mom & pop diner that knows your order by heart, the gym you've belonged to for 20 years, or the jewelry store

where you bought your engagement ring, local businesses are the lifeblood of the community.

7/29 \$700,000 from the City's Small Business Relief Fund to Help Small Businesses in Historically Underserved Communities

Mayor Faulconer, Councilmember Montgomery and local business leaders announced \$700,000 from the City's Small Business Relief Fund will go toward helping businesses in historically underserved communities.

The funding will aid recovery efforts for businesses through specialized outreach, technical assistance, and direct grants to possibly hundreds of business owners. The City Council will consider this reallocation of funds next week.

7/28 City Council

The City Council voted on several items this week. Some key items were:

- Extension of Repayment Period Related to the Residential and Commercial Eviction Moratorium
 Due to the Declared State of Emergency from COVID-19
 - An amendment was accepted that extends the repayment period until December 30,
 2020 instead of the original proposal of March, 2021.
 - This item passed 5 4, but before being enacted it will need undergo a second vote and be subject to the possibility of a Mayor veto.
 - I voted "No" on this item read my statement <u>here</u>.
- Consideration of Potential Amendments to Governing Regulations Regarding City Boards and Commissions.
 - \circ This item passed 8 1.

Federal Loans Available to Help Small Businesses Affected by Civil Unrest

Low-interest federal disaster loans are available to help San Diego County small businesses affected by the civil unrest that began May 26, 2020, and do not have the financial ability to offset the adverse impact without hardship.

The loans are not intended to cover losses from property damage, nor are they general COVID-19 related assistance.

The deadline to apply for the loans is April 7, 2021.
