Street dining on Avenida de la Playa in La Jolla Shores

Council President Pro Tem Bry has asked the City Council to consider waiving permitting fees for temporary street dining on Avenida de la Playa between El Paseo Grande and Calle de la Plata.

Thank you to Phil Wise and other restaurant owners who are working with the City to open the street for evening dining on weekends through the summer. Discussions are also underway about similar temporary dining in The Village.

Recommendation for Slow Streets in La Jolla

The Council President Pro Tem forwarded the La Jolla Community Planning Association's recommendation to the Mayor for Coast Blvd and Hillside Drive to be turned into Slow Streets. We hope to hear back soon from the Mayor and traffic engineering.

7/1 City Resumes Parking Enforcement

The City of San Diego resumed enforcement of all parking regulations on Wednesday, July 1. The enforcement will begin with a two-week grace period, during which violators will receive written warnings. Citations with corresponding fines will be issued beginning Wednesday, July 15.

6/30 City Council Votes

The City Council voted on several items this week, with all items passing. Some key items were:

- Item 50 Actions Related to the Approval of the Purchase and Sale Agreement for the City's Sale to SDSU of Approximately 135.12 Acres of the SDCCU Stadium Site in Mission Valley.
 - Escrow should close in August, with construction on the new stadium beginning shortly afterwards.
- Item 101 Extension of Residential and Commercial Eviction Moratorium until September 21 Due to the Declared State of Emergency from COVID-19.

- Item S500 Authorization to Expend \$15,100,000 in CARES Act Federal Funding to Establish a COVID-19 Emergency Rental Assistance Program in the City of San Diego.
- Item 331 Contract with Deloitte Consulting, LLP, for Get It Done System and Salesforce Platform Application Development, Maintenance, and Support.

6/24 San Diego Adopts Policies For Officers To De-Escalate, Intervene Against Unreasonable Force

The San Diego Police Department has created standalone policies to help officers reduce the use of force and increase community trust.

The department's new standalone de-escalation policy now requires officers to exercise techniques that seek to resolve situations through voluntary compliance or with lower levels of force. A second policy has been added to require officers to intervene if another officer uses unreasonable force and report the incident to a supervisor.

Technology overhaul coming to San Diego council meetings

San Diego is planning technology upgrades to its City Council chambers. The renovations will include new lighting, a new sound system, modernized video displays and an upgraded voting system for the council. Additionally, members of the public also will have more freedom to show their own slides or photos during testimony.

Renovations are scheduled to begin in August.

7/2 San Diego County to Be Placed on State Watchlist

San Diego County has been notified that it will be placed on the State's "Monitoring List" on July 3. Given the continuing high number of daily cases, it is expected that the County will be on the state's watchlist for the next three days and the County could be forced to mandate more restrictive measures and additional closings as early as July 7.

Additional closing could include dine-in restaurants (outdoor, pick up or drive-through can occur,) wineries and tasting rooms, movie theaters, family entertainment centers, cardrooms, museums and zoos

6/30 San Diego Restaurants to Close Nightly at 10 PM

San Diego restaurants must close nightly at 10 p.m. starting Wednesday, July 1 until further notice. Additionally, bars, wineries, distilleries and breweries that are allowed to serve food must also close nightly by 10 p.m. and must remain closed until 5 a.m..

7/1 - Governor Newsom orders indoor restaurants, wineries, movie theaters to close in 19 Counties

Effective immediately, Governor Newsom is instructing certain sectors to close indoor operations for three weeks in counties that have been on the state's watch list for three consecutive days. The affected sectors are: restaurants, wineries, movie theaters, family entertainment centers, zoos, museums and cardrooms. While indoor operations are mandated to close, businesses can still operate outdoors.

This closure applies to 19 counties as of Wednesday. Those 19 counties represent more than 70% of the state's population and include Los Angeles, Orange, Riverside, San Bernardino and Ventura.

6/30 - Governor Newsom Signs Executive Order on Actions in Response to COVID-19 6.30.20 Governor Gavin Newsom issued an executive order extending authorization for local governments to halt evictions for renters impacted by the COVID-19 pandemic, through September 30.

The order also extends provisions in earlier orders which allow adults to obtain marriage licenses via videoconferencing rather than in-person during the pandemic; waive eligibility re-determinations for Californians who participate in Medi-Cal, to ensure they maintain their health coverage; suspend face-to-face visits for eligibility for foster care; and permit In-Home Supportive Services (IHSS) program caseworkers to continue caring for older adults and individuals with disabilities through video-conferencing assessments.
