City Employees Can Earn Sick Leave

Councilmember Gloria was joined by Assemblywoman Lorena Gonzalez, Council President Pro Tem Emerald, and city workers to announce the implementation of earned sick days for hourly city employees.

On April 27, the San Diego City Council unanimously approved my proposal to provide earned sick leave for hourly city employees to comply with A.B. 1522, the Healthy Workplaces, Healthy Families Act of 2014.

City employees are committed to San Diego, and allowing them to earn sick leave will help ensure their continued ability to serve the public in a healthy and productive way. When I learned that over 1,300 of our employees, many of whom worked closely with the public, didn't have the ability to take sick days, I knew something had to be done. Providing workers with fair pay and benefits is always a good investment.

A.B. 1522 was authored by Assemblywoman Lorena Gonzalez and entitles individuals working in California for 30 or more days within a year to paid sick leave of no less than one hour for every 30 worked. The law, which goes into effect July 1, 2015, allows employees to earn up to three sick days per year. As a charter city, San Diego had to take steps including meeting and

A Progress Report on Ending Homelessness

Councilmember Todd Gloria, as Governance Chair of the San Diego Regional Continuum of Care Council (RCCC), presented an update on efforts to end homelessness at the April 15 Public Safety and Livable Neighborhoods Committee.

The RCCC is the federally recognized planning entity for homelessness issues in the region charged with the responsibilities required under the HEARTH Act for the regional Continuum of Care. The RCCC includes all of the geography within the County of San Diego, including 18 incorporated cities and all unincorporated areas. This is a collaborative effort of diverse stakeholders working together as a system of programs to increase success.

The RCCC brings in more than \$16 million annually of federal competitive dollars for homeless housing and services. Among the RCCC's goals are:

- Coordinated Assessment and Entry to ensure people are matched to appropriate services and housing and prioritized based on need:
- · Permanent Supportive Housing targeted to people with the most significant challenges;
- Rapid Re-housing targeted to people with fewer barriers to housing stability; and
- · Housing First orientation of entire system toward removing barriers and assisting people to access appropriate permanent housing, with right level of services, as quickly as possible.

The RCCC also announced in April that the annual count of San Diego County's homeless population found that there were 8,742 people living on the streets or in shelters, a 2.8 percent increase from last year.

The WeAllCount Campaign, also known as the Point-in-Time Count, was held in the early morning hours on January 23, 2015. This annual effort helps determine the number and location of homeless individuals in the San Diego region and is critical in securing more than \$16 million dollars in federal funding for needed housing and services.

"The results of the WeAllCount census prove that more must be done to help end homelessness in our region and we still have a long way to go to reach that goal," said San Diego City Councilmember Todd Gloria, who chairs the RCCC. "The RCCC's efforts over the past year to better utilize our limited funding will help move more people off the streets, and we need to more strongly advocate for an update to the antiquated federal funding formula for homeless services so we can secure sufficient resources to address this growing issue."

The Point-in-Time Count found that the number of unsheltered homeless individuals in San Diego County was 4,156, an increase of 4.3 percent from last year, while the number of homeless persons in shelters was 4,586, up 1.4 percent. Of the unsheltered population, an estimated 2,911 – or 70 percent – were males and an estimated 631 – or 15.4 percent – were veterans. Almost 28 percent of those who live on the street are estimated to suffer from either addiction or severe mental illness. More than 70 percent of those living on the street reported having been homeless for a year or longer.

Strengthening Public Safety

- Fulfilling a request he received at a recent Joint Meeting on Crime, Councilmember Gloria delivered all-way stop signs for the intersection of Fort Stockton Drive and Randolph Street. This will make walking in the neighborhood even safer, especially for the students of Grant School.
- SDPD cited an illegally operating mobile food vendor in the 400 block of F Street after Councilmember Gloria received complaints.
- A streetlight was repaired at Ninth Avenue and Cedar Street.
- The sidewalk in the 4700 block of Panorama Drive was patched.
- A utility box that had exposed wiring in the 3700 block of Goldfinch Street was repaired with assistance from AT&T.
- A trip hazard was removed from Ray Street south of University Avenue.
- A fire hydrant was repaired at Ohio Street and University Avenue
- A sewer waste access cover was repaired in the 2500 block of Boundary Street.
- Four new mid-block street lights were installed on 35th
 Street between El Cajon Boulevard and Meade Avenue.

Infrastructure Investment

- After initially being skipped for a surface overlay after recent infrastructure improvements, work on Ivy Lane was completed on April 23.
- Road repair work was completed in the 3500 block of Florida Street, in the alley between 30th and Kansas Streets north of Meade Avenue, and in the alley parallel to the 4600 block of 30th Street.

- New amenities including two new picnic tables, one bench, and one hot coal disposal bin, are being installed at Ward Canyon Park after the old versions were badly damaged by an automobile in October 2014.
- The Downtown Parking District is purchasing bike racks.

- SDG&E poles were removed from 30th Street in South Park and new city light poles were activated.
- A water meter was repaired in the 3500 block of Fir Street.

Community Character

- After one year of seeking assistance from city departments, a resident on the 3600 block of Richmond Avenue contacted Councilmember Gloria to request tree trimming.
 The troublesome trees were trimmed within one week.
- News rack concerns were addressed at the southwest corner of 29th Street and University Avenue and the southeast corner of 30th and Dwight Streets.
- "No Parking Street Sweeping" signs requested by neighbors will soon be installed on Third Avenue between Redwood and Spruce Streets.
- A two month pilot program is underway for franchise refuse haulers to pick up and return trash bins inside the businesses in the Gaslamp Quarter to decrease scavenging and littering.
- Two couches were removed from the 3000 block of Elm Street.
- A trash can was repaired at the northeast corner of 30th and University Avenue.
- Graffiti was removed near University Avenue and 30th Street.

San Diego Updates Nondiscrimination Policy

On April 7, Councilmember Todd Gloria announced the City Council approved an amendment to add gender identity and gender expression as types of unlawful discrimination to the City of San Diego's Nondiscrimination in Contracting Ordinance.

"San Diego stands against discrimination. Today's action demonstrates that by ensuring the city will not award contracts to any business that discriminates against anyone, including transgender people," said Councilmember Gloria.

Gender identity refers to both an individual's sense of self regarding characteristics labeled as masculine, feminine, both, neither or in-between. Gender expression means a person's gender-related appearance and behavior whether or not stereotypically associated with the person's assigned sex at birth. The State of California Government Code includes both as protected classes for purposes of employment.

In the fall of 2014, the Human Rights Campaign released its annual Municipality Equality Index, a point based system that examines a city's laws and policies based on their inclusivity of the LGBT people who live there. San Diego scored exceptionally well, earning 100 out of 100 points. A few of those were considered bonus points, meaning there was still an area the city could improve. The city missed two points because its City Contractor Non-Discrimination Ordinance did not include gender identity.

"Even with an A+ for equality, I knew we could do better," said Councilmember Gloria, who worked with city staff on the development of the amendment.

With this action, the types of unlawful discrimination will be listed as: "race, gender, religion, national origin, ethnicity, gender identity, gender expression, sexual orientation, age, or disability" in four sections of the San Diego Municipal Code, Chapter 2, Article 2, Division 35. The city's Human Relations Commission and the Police Department Citizens' Review Board both recommended the update. The Budget and Government Efficiency Committee unanimously recommended approval at its meeting on March 18.

Bud Kearns Pool Renovations Update

The main drain at Bud Kearns Memorial Pool needs to be replaced and upgrades need to be made to the filtration system and sump pump. Other improvements to the fence and pool area may also be mandated by the County Department of Health. The pool will not be re-opened until the repairs are completed. An early estimation of the worst case scenario is that it could take nine months and cost up to \$1.2 million to fix. The best case scenario is that the pool will be allowed to re-open after the drain is repaired at a cost of less than \$200,000 in approximately two months, as long as a commitment is made to address the rest of the repairs as soon as possible. Free Tree Program from Urban Corps

Urban Corps, a local non-profit organization, plants trees in public right-of-ways in partnership with the City of San Diego. Residents

Downtown Update

<u>FORM15 Opening:</u> On April 16, Councilmember Todd Gloria helped cut the ribbon on FORM15, a mixed use apartment project located on 15th and Market Street in East Village. The project includes 242 residential units, neighborhood serving retail space, dedicated open space for the public, electric charging stations for residents, a dog run, and a pet washing station for residents.

<u>Downtown Hospitality Zone Parking Pilot Results:</u> In 2014, at the request of Civic San Diego, the City of San Diego implemented a pilot program to change parking meter enforcement times in Downtown's Hospitality Zone from 8:00 a.m.—6:00 p.m. to 10:00 a.m.—8:00 p.m. to increase parking spot turnover. In the Hospitality Zone, which is bound by First Avenue, Seventh Avenue, Broadway, and Harbor Drive, both parking space utilization and revenue increased dramatically during the pilot program. Parking space utilization grew to 80%, an increase of 45%. Revenue increased 46%. The parking meter enforcement times will remain 10:00 a.m.—8:00 p.m. for the foreseeable future, though further changes and an expansion of impacted area are under consideration.

Construction Underway on Downtown Rapid Stations: SANDAG has begun a new phase of construction on the Downtown Rapid stations. The three stations being constructed can be found on the south side of Broadway between First and Front, in front of 101 West Broadway; the north side of Broadway between Union and Front, in front of the old San Diego County Courthouse; and on the east side of India Street, north of Broadway, between B and C, near One America Plaza. Construction is expected to last five months through this fall. The new stations will be uniquely branded and feature shelters with a sleek, contemporary design, as well as digital displays announcing next vehicle arrival time. Additional improvements include new sidewalks, ADA-accessible curb ramps, and roadway paving and striping.

During construction, access to businesses and office buildings is being maintained. Construction will occur primarily on weekdays although some night and weekend work will be necessary in order to reduce traffic impact. A total of 11 Rapid stations will be built in Downtown to serve Rapid 215, 235, 280, and 290. Three have been completed and are open for service. Construction of the remaining eight stations is being split into two phases. The first phase, as mentioned earlier, will be completed in the fall. The second phase is scheduled to be completed in spring 2016. Dolores Diaz, Executive Director of the Regional Task Force the Homeless, which coordinates the WeAllCount event on behalf of the RCCC, said it was a record-breaking year in terms of community engagement with 1,488 volunteers working out of 28 deployment centers throughout San Diego County to help count and survey homeless individuals.

"While the increase in the number of homeless persons is disappointing, it is critically important to know this information so we can ensure continued funding for much needed housing and services to effectively address homelessness in our communities," Diaz said.

The RCCC's next steps include advocating for more federal funding and expand other fundraising efforts, regionalizing the Downtown CAHP system; continuing to monitor currently funded programs for efficacy; continuing to establish a data driven housing and service system; and continue assessing appropriateness of housing programs and services to meet needs.

conferring with its employee organizations in order to implement earned sick leave. Most City employees earn annual leave which can be used for either vacation or sick time. Over 1,300 City employees, including recreation leaders, seasonal lifeguards, and library staff, are not currently eligible for annual leave and will now benefit from sick leave through the implementation of A.B. 1522.


Addressing the needs of workers is an ongoing interest of mine. After championing the successful approval last year of a measure that increased San Diego's minimum wage to \$11.50 per hour and provided earned sick leave of up to five days per year, corporate interests challenged the compromise measure through a referendum, forcing the item onto the June 2016 ballot. While that implementation is paused, I'm excited that Assemblywoman Gonzalez secured three earned sick days statewide. For more about the new law: www.CAPaidSickDays.com.

City employees will be able to earn sick leave starting July 1. The Department of Financial Management has estimated that implementation of up to 24 hours of paid sick leave to hourly, non-benefitted City employees will have a financial impact of approximately \$471,284 per fiscal year.
