JULY 20 | PS & LN

SPECIAL MEETING ON ADDRESSING HOMELESSNESS IN SAN DIEGO

On July 20, the PS&LN Committee held a special meeting to discuss and explore solutions around homelessness in our City. It is our duty to respond to this growing issue of our most vulnerable populations, including unhoused residents. I look forward to diving further into how this issue impacts District Four to ensure we address any inequities in the services provided by the city.

AUGUST LEGISLATIVE RECESS

Due to scheduled legislative recess, there are no City Council or Committee meetings from August 3rd through September 7th. This is a time for our office to focus on a plan for the services we provide to you, including a strategic communications plan, upcoming policy advocacy, and addressing constituent issues. JULY 18 | CITY COUNCIL

SURVEILLANCE ORDINANCE

After two years of delay, the Surveillance Ordinance was passed by City Council, with an exemption for San Diego police officers who serve on federal task forces. As a champion for this ordinance, Council President pro Tem issued the following statement: "As elected officials, we must prioritize a balance of both public safety and civil liberties for the people we serve. The passed exemptions continue to cause concern, given the history of surveillance against our most vulnerable communities. However, the community wants to feel safe, and these oversight mechanisms over the city's surveillance technologies bring us closer to transparency while improving safety for our residents."

JULY 19 | CITY COUNCIL

DISPARITIES STUDY RECOMMENDATION IMPLEMENTATION

I have advocated for this Disparities Study to assess whether minority-owned businesses face any barriers as part of the City of San Diego's contracting processes since the first day I took office. When the data was released for review, it highlighted apparent disparities and inequities within the current system. This month, City Council approved the recommendations to implement and address those equity gaps. Though this is a win in our fight to achieve equity, we still have work to do in our fight for economic justice.

JULY 26 | CITY COUNCIL

101 ASH STREET AND CIVIC CENTER PLAZA SETTLEMENT AGREEMENT

This month, City Council voted to settle ongoing litigation in the dispute of the 101 Ash Street and Civic Center Plaza properties. With her opposing vote, Council President pro Tem released the following statement: "I am disappointed in the decision Council made to settle this case. I remain concerned about the Capital Improvement Project funds, being responsible for indemnifying Cisterra, and ultimately, not having a robust plan for this real estate. We owe our City residents a thorough and transparent process with a holistic resolution. But, we can only hope for a better outcome as we plan the future endeavors of these acquired buildings."

As a critical component to my commitment to clean, safe, and healthy neighborhoods, my office is partnering with local waste management companies for a **#DumpsterDays event.**

COMMUNITY VOTE!







The Southeastern Community Mobility Roadmap is a community-developed plan that engaged multigenerational Southeastern community members to share their current transportation priorities and their vision for the future of transportation in Southeastern. With funding from Supervisor Nathan Fletcher's office and the California Air Resources Board, Pueblo Planning partnered with GRID Alternatives, Greenlining Institute, and four Southeastern community-based organizations (I Am Green, The Urban Collaborative Project, Project New Village, and San Diego Urban Sustainability Coalition) to engage community members in Southeastern and co-develop the mobility roadmap.

Due to the community engagement efforts, the planning team and community-based organizations successfully advocated for \$1.5 million in the City of San Diego's budget to implement a couple of the community's main priorities shared during the engagement process. This year's City of San Diego budget includes \$700,000 for 47th Street and Hilltop's Drive Safe Streets (adjacent to Gompers Preparatory Academy); and \$800,000 for street lights placed near parks, schools, and key transit stops in Southeastern District 4!

Additionally, \$100,000 is available for the community to vote on how to spend. The process of the community deciding how to spend a budget is called participatory budgeting. Through the planning process, community members identified current transportation needs and their vision for the future of transportation. Our team identified three pilot projects from that list of priorities that could fit within that budget and be implemented relatively quickly for the community to vote on.

- · E-Bike Ownership Program: Approximately 75 e-bikes with locks, helmets, and baskets for 75 recipients.
- $\bullet \ \text{E-Vehicle Sharing Program: The purchase of one e-vehicle that a local Community-based organization will } \\$ manage for a community car-sharing program.
- · Community Beautification: Wayfinding (signage that shares key areas to walk or bike to) and Community


